Superintendent – If you haven't seen on Facebook, it is also on our website; we are currently accepting bids on two of our old buses, bus six and bus seven. We will be accepting those bids through the end of this month and unsealing them at next month's board meeting. April is using; we have one bus, that is, it has actually been stripped of parts even, and April came up with a great plan. She is working with local law enforcement and emergency services. One of these days, when there is no school, they are going to stage a bus accident, go ahead and tip it on its side, its wrecked, before they go ahead and hall it off to Croads. Let all the local EMS crews have practice with that before it heads off to Croads. A couple other things: the Robotics preseason opener is coming up at the end of this month in Midland, the last weekend in October. We do have MSU extension coming in the week of November 6th –10th. They will be doing a babysitting course here students will be certified as a babysitter with first aid and CPR certification. It is for students aged 11-19. That will be going home with them soon, so they can sign up for that. We also did sign up for a program to get the free air purifiers for each classroom. We signed up this summer, and I did reach out to the state to ask where they were. I

was told they were ordered in bulk, and they are waiting for that order to process. So, they are continuing to collect from other schools. When that goes through, we will have a new one in each classroom, and I think they provide five filters for them, too, so it's quite a long time. The other thing I just want to take a minute and recognize October is National Principals Month. I know I've been in those shoes. The things that Mrs. Benson and Mr. Mix do in a day and a week that, things you see pale in comparison to the things you don't see, so if you see them, take a minute to thank them for everything that they do for our school.
