The Fannin County Board of Education met in regular session with the following members present: Bobby Bearden, Chairperson; Garnett Webb, Vice-Chairperson; Junior Farmer; Terry Bramlett; and Emily Dunn. All members present.

Moved, seconded, and carried to approve the agenda.

Moved, seconded, and carried to approve the minutes from all previous meetings.

Moved, seconded, and carried to approve the financial report for the month ending June 2007.

Public Comment:

Dan Long, a bus driver for Fannin County Schools, stated he wanted to see if the board had considered his request from June regarding revising the policy on paying out sick days when a PSERS employee retires. Mr. Long stated he was an employee who took few sick days over the past 28 years with Fannin County Board of Education he stated that he would like to receive full pay for each sick day that he had remaining once he retires.

Mike Earley, spoke on behalf of the Fannin County Quarterback Club. Mr. Earley stated that he, along with other members of the Quarterback Club, were concerned about the plans for the football stadium. Specifically they are concerned about the size of the proposed field house, weight room, and concessions stands. Mr. Earley stated he had a letter for the board addressing these issues, and, after talking to other concerned citizens, he would revise this letter and present the revision to the board with the specific concerns.

Angela Berrong, Director of School Improvement and Instructional Services, gave an update on the School Improvement process for the system and introduced the "Keys to Quality – Unlocking Continuous Improvement" manuals and software that the Georgia Department of Education has provided school systems to help with the school improvement process.

Betsy Hyde, Director of Student Services, shared with the board the results of the latest Special Education Compliance which was performed by the Georgia Department of Education. This review states the Fannin County School System meets requirements of Part B of the Individuals with Disabilities Education Act.

Art Hubbard, Assistant Superintendent, gave the board an update on the various construction projects (see attachment). Mr. Hubbard also discussed options with the board on the upcoming football stadium project.

Moved, seconded, and carried to approve a maximum class size resolution authorizing the Superintendent to establish maximum class sizes in grades 9 to 12 at the maximum limits allowed by law (see attached).

Mark Henson, Superintendent, gave the board summary discipline reports for school year 2006-07 for the middle and high school.

Moved, seconded, and carried to go into executive session to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee; (O.C.G.A. 50-14-3(6)); and to discuss the future acquisition of real estate; (O.C.G.A. 50-14-3(4)).

Moved, seconded, and carried to resume regular session.

Bobby Bearden, Chairman, announced no action was taken while in executive session.

Moved, seconded, and carried to accept the resignation of Patsi Brantley and Pat Holloway.

Moved, seconded, and carried to employ Melissa Beaver, Margie Kolesky, and John Sellars as bus drivers.

Moved, seconded, and carried to approve Pat Holloway as a substitute teacher for the 2007-08 school year.

Moved, seconded, and carried to authorize Mark Henson, Superintendent, to condemn the minimum amount of additional land at fair market value that will be required to complete the stadium complex project. Listed are the reasons for doing this:

- The Grand Jury, in November, 2004, recommended that we renovate the stadium which does not meet current standards.
- We feel that the students and citizens of Fannin County will benefit in many ways from a new stadium.
- The existing stadium track is too short to qualify for regional and state events.

- Southern A & E, our architectural consultant, has determined that the only viable option fiscally and environmentally is to extend the stadium complex in a southeast direction.
- The cost to relocate the stadium would be a huge financial burden to the taxpayers of Fannin County.
- If the stadium had to be relocated, students would have to leave the campus to use the stadium, and we believe that that is not acceptable.
- We do not want the liability of two stadiums.
- We have offered to buy the land needed for the new stadium for fair market value by registered letter from the owners, Sharon A. Rogers and Brenda Denise Lambert, and have received no response.
- No residents will be displaced from their home.

Board Members' Comments:

Emily Dunn stated she was excited about the upcoming school year.

Terry Bramlett stated he appreciated the presentations given by Angela Berrong, Betsy Hyde, and Art Hubbard.

Junior Farmer stated he was thankful for a good start to the school year.

Garnett Webb stated he appreciated Dan Long for coming out and for his comments. Mr. Webb further stated he personally had a good week because he was able to visit all five schools.

Bobby Bearden stated he appreciated the article Cynthia Panter did on Senate Bill 10 that appeared in *The News Observer*.

Superintendent's Comments:

Mr. Henson stated he was thankful to the entire school system staff (teachers, paraprofessionals, school nutrition workers, bus drivers, secretaries, and administrators) for a smooth start to the school year. Mr. Henson also stated he appreciated the job Betsy Hyde performed as Special Education Director. Mr. Henson asked Benny Long to review Fannin's outdoor activities: extreme weather condition plan with board members. After Mr. Long reviewed this plan with board members, Mr. Henson stated that even if the wet bulb temperature was below 82 Fahrenheit, the administrator could still request children be moved inside or the event cancelled if the administrator felt conditions were too hot. Mr. Henson also presented board members with certificates from The Georgia School Boards Association stating they had successfully completed board member training activities sponsored by the Georgia School Boards Association.

There being no further business to come before the meeting, upon motion duly made, seconded, and carried, the meeting adjourned subject to being called into special session by the chairman when deemed necessary.
