Principals Report: Debbie Lynch

Second semester starts next week, and several upper classmen are taking college classes. Five students are involved in school to work, and Running Start Biology will be offered.

The basketball teams are doing well this year. We will be doing the Kids Heart Challenge in the spring. Games will begin on the new gym floor this week. Hussey will be coming to raise the basketball hoops. Debbie has ordered a new flag for the wall and Dawn received an Indian Stream Republic Flag to go on the wall as well.

Superintendent Report: Dana Hilliard

January Report – Last Thursday was in Canaan for the second series of the North Country Gathering. The workshop focuses on how the towns can partake in a more collaborative model and share resources. Canaan Superintendent and Business Manager sat down with Bridget and Dana last Friday to discuss the positions that they can share with SAU #7 and if we have need for them. These discussions will be ongoing. Dana also had discussions with the state regarding teachers that come to NH from Canaan must have a NH certification. If the teacher is not certified in NH, then SAU #7 would pay to have that teacher become NH certified. The teachers would need to have the certification or be in the process of obtaining it before coming to work in NH. Vermont students still cannot come to NH schools. Dana has asked Jen (Canaan Superintendent) to continue putting pressure on the state to get this changed. Also, per Canaan's Collective Bargaining Agreement (CBA) the teachers cannot be forced to come and teach at SAU #7 schools. Dana will continue to work with Debbie to see what positions we may have open that we could utilize Canaan teachers however, Dana will continue to look at all the needs and make the best choices for Pittsburg School and SAU #7.

Attended the North Country Superintendent meeting last week. All Superintendents are busy with budgets. There is a Joint Policy Committee meeting this Thursday at Stewartstown Community School. Dana has the Safety Audits that he will be reviewing later during this meeting in non-public. On the 27th of this month will be attending the New Hampshire School Administrators meeting.

Open Board Member Seats 2025 – Lindsey's 3-year term is up and Dan's 1 year term will be up this year as well. Dana thanked the board members for their service.

Would like to have the board approve the 2025/2026 Budget with approved severance included. It is proposed that the 2025-2026 proposed budget move forward to the public hearing for a total of \$4,139,157.00. With an increase of \$0.42 per thousand or a total of \$5.62 per thousand. The budget is decreased by \$105,171.00 from the previous fiscal year. Total amount to be raised by taxes is \$3,358,157.
