RESOLUTION TO ACCEPT STATE SUPPORT AND GUIDANCE

WHEREAS the State Superintendent of Education has offered support and guidance in the areas of academics, personnel, and finances to the Sumter County Board of Education under the *Educational Accountability and Intervention Act of 2013* (§§ 16-6E-1 through -7, Ala. Code 1975);

WHEREAS the Sumter County Board of Education acknowledges that assistance from the State Superintendent is in the best interest of all Sumter County School System students;

WHEREAS the Sumter County Board of Education authorizes the Sumter County Superintendent to provide any and all information the State Superintendent requests to effectuate the assistance provided by the Alabama State Board of Education.

NOW, THEREFORE, BE IT *RESOLVED*, that the Sumter County Board of Education does hereby fully acknowledge, agree, and accept any intervention assistance from the State Superintendent of Education under the authority allowed him under the *Educational Accountability and Intervention Act of 2013* (§§ 16-6E-1 through -7, Ala. Code 1975) and does consent to any authority provided by law should the Alabama State Board of Education exercise its authority in the form of a formal ratified Resolution related to the statutes referenced herein.

BE IT FURTHER *RESOLVED*, that the Sumter County Board of Education will cooperate with the State Superintendent of Education and the Alabama State Board of Education to improve student achievement and financial stability within the Sumter County school system.
