MINIMUM QUALIFICATIONS:

- Valid Michigan Elementary Teaching Certificate with Special Education Endorsement
- Physically and mentally capable of rigorous work (capable of sitting on the floor, standing, and sitting for extended times, and lifting or pushing a minimum of 40 pounds)
- Pass and maintain School Employment background check

ESSENTIAL DUTIES MAY INCLUDE BUT ARE NOT LIMITED TO:

The Special Education Teacher may require traveling between one or more Huron County Rural Schools, via a personal vehicle, to provide specialized instruction to students receiving special education.

- Experience and skills necessary to coordinate and implement a student special education program.
- Provide specialized instruction in a positive environment.
- Establish clear objectives for all lessons and communicate those objectives to students.
- Use research-based effective practices in assessment, instruction, and decision making.
- Create a plan and instructions to achieve and monitor progress toward individual goals and objectives for each student.
- Maintain student safety in all situations and utilize effective behavior management and positive behavior support strategies, including CPI strategies.
- Conduct ongoing assessment of student progress.
- Collaborate with parents, administrators, testing specialists, social workers, and other professionals to develop individualized education programs (IEPs).
- Complete and maintain paperwork associated with position responsibilities.
- Be accurate, efficient, and timely in compliance with state and federal rules and regulations for special education.
- Communicate professionally and build positive relationships with students, staff, administrators, parents, and community agency personnel.
- Consistent, in-person attendance.
- Any other duties assigned by the Board of Education or the Superintendent.

- Non-union position, \$ 50 - \$ 70 an hour, based on experience.

- FTE: .25 (part-time), hours/days to be determined based on 25/26 SY student needs.
