School Responsibilities

Ella Grant Elementary School will:

Ella Grant Elementary School offers a high-quality curriculum by highly qualified faculty and staff. The leadership team conducts a comprehensive needs assessment and sets goals through our Continuous Improvement Plan (CIP). Our supportive faculty provides rigorous instruction in a student-centered learning environment with minimal disruptions and distractions. All teachers are trained through ongoing professional development that enables them to instruct students at various levels and in a variety of ways to meet academic challenges.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:

All initial parent-teacher conferences will be held first semester. During these conferences, teachers will discuss quarterly academic curriculum and grade level expectations.

3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:

Parents receive a student handbook annually and a monthly school bulletin. Each quarter, parents will receive mid-quarter progress reports to keep them informed of their student's academic progress. Teachers send home weekly or monthly reports to parents. Parents may also check their child's grades on Schoology at any time to see their child's progress.

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

Our staff will be available for conferencing during teacher planning times, before and after school to accommodate a parent's work schedule.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Parents are encouraged to participate in school events. Parenting events are held monthly to allow parents the opportunity to become involved. We welcome participation on the Parent Advisory Council and the Continuous Improvement Plan Committee.

6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.
