Superintendent Report: Dr James Whitfield, Superintendent

2024-25 Budget Amendments:

Amended SAFE Cycle Grant among functions according to NOGA. Staff decrease and movement effected August accruals, amended functions accordingly. Decrease in students from K-12 to K-6 effected After School Care.

SK presented the 2025-26 Budget for approval and explained where the money in each column comes from (ie. Math Grant, TRA, SSRA, Federal Funds, etc.) and how the TRA and SSRA are to be paid under HB2. Also spoke of utilities and waste management bills dropping slightly with the change in staff/students on campus.
