

AFFIDAVIT OF CUSTODIAN REGARDING SCHOOL RESIDENCY

Illinois law provides that a person who knowingly enrolls or attempts to enroll in the schools of a school district on a tuition-free basis – a pupil known by that person to be a nonresident of the district – will be guilty of a Class C misdemeanor. Illinois law also provides that a person who knowingly or willfully presents to any school district any false information regarding the residency of a pupil for the purpose of enabling that pupil to attend any school in that district without the payment of a nonresident tuition charge, will be guilty of a Class C misdemeanor. (105 ILCS 5/10-20.12b)

The undersigned, having been first duly sworn, on oath, states as follows:

1. This affidavit is given regarding the admission of the following named child or children to Liberty Community Unit #2 School District, Adams/Pike Counties, Illinois (herein “School District”), or the residency status of such child or children.

3. I have legal custody of the child or children as follows: (NOTE: Check only one)

- I am the natural or adoptive parent.
- I have custody by order entered in _____ County, _____, in Case No. _____, for reasons other than to have access to the educational programs of the School District.
- I have legal guardianship by order of court entered in _____ County, _____, in Case No. _____; this guardianship was established for reasons other than to have access to the educational programs of the School District.

- I have custody under a statutory short-term guardianship; I recognize that within sixty (60) days of the child or children's enrollment, a court order must be entered that established permanent guardianship and grants custody to me for reasons other than to have access to the educational programs of the School District.
- I am the adult caretaker of the child or children and I am receiving aid under the Illinois Public Aid code for the child or children who reside(s) with me for purposes other than to have access to the educational programs of the School District.
- I have assumed and exercise legal responsibility for the child or children and provide the child or children with a regular fixed night-time abode (or home) for purposes other than to have access to the educational programs of the School District.
- I am a foster parent or the child has been placed with me by the Illinois Department of Children and Family Services.

NOTE: The School District may require copies of any custody orders. Also, additional information may be required to establish the reasons for residency. Additional information may be attached.

3. The child or children reside with me as their true bona fide residence.
4. No other person, except the undersigned, has legal custody of the child or children or exercise legal or parental responsibility for the child or children.
5. I am of legal age, under no disability, and if called upon to testify, could competently attest to the foregoing facts, matters and things.
6. If this affidavit is signed by more than (1) person, we are each separately making this affidavit.

This affidavit is given, in part, to induce the Board of Education of the School District to admit such child or children as a resident(s) of said school district. I recognize that if found to be a non-resident, I am obligated to pay and agree to pay tuition as required by applicable law, rule or regulations, together with any costs or expenses, including attorney fees, incurred by said Board of Education to collect such tuition. If any change in the information set forth occurs, I will notify the Superintendent or Principal.
