This Transfer Agreement establishes the terms and conditions for th	e listed student(s) to attend the Natalia ISD as a transfer student(s)
for the 2023-2024 school year. The student(s) is/are a resident(s) of	ISD.

The parent or guardian (signed below) requests that the student(s) be permitted to attend district schools in the 2023-2024 school year and agree to the following terms and conditions for that transfer:

This transfer is effective for the 2023-2024 school- year only. District approval of this transfer creates no right or expectation that the student will be admitted as a transfer for any subsequent school year. Students must be pre-approved annually. It is understood that acceptance of transfer is judged partially upon the student's attendance, discipline, and scholastic records from the previous school year.

It is understood that acceptance of transfer is judged partially upon the student's attendance, discipline, and scholastic records from the previous school year.

It is understood that acceptance of transfer is also based upon available classroom space. Student must maintain acceptable levels of attendance, academic achievement, and compliance with the NISD Student

Code of Conduct throughout the entire school year. Acceptable levels are defined as: 92% attendance, maintaining passing grade average, and maintaining good conduct in all classes, this includes tardies.

The superintendent of NISD may revoke the transfer of a student who fails to maintain an acceptable level of attendance, academic achievement, or compliance with the NISD Student Code of Conduct for the next applying year. If this agreement is revoked, revocation ordinarily will be effective at the end the current year.

The parent or the student shall be responsible for transportation to and from the district school to which the student is assigned. Except as modified by this Transfer Agreement, the student shall be subject to all policies, regulations, rights, privileges, and responsibilities of enrollment in the district as if he or she resided in the district.

The District and parent or guardian agrees that this Transfer Agreement is the entire agreement controlling the admission and enrollment of the student in the Natalia ISD for the 2023-2024 school-year.
