The Concurrent Teacher Pay rate will be per classroom at \$125.00/day (the daily rate of a certified substitute). Divided classrooms will result in division of the daily certified substitute rate between classroom teachers Maximum of three (3) classroom teachers, Cost: \$125.00/day, Source of Funds: ESSER III

- N. Approval of Positive Behavioral Intervention and Supports (PBIS/MTSS), an evidence based program which includes ongoing Tier I coaching for BCMS, BCHS, and New Horizon Alternative School. PBIS includes 2-day training with the PBIS leadership team. There will be ongoing coaching after the 2-day training (please see attachment for additional services). Individual (TIER 1, TIER 2 & TIER 3) Counseling: \$50 per 30-minute unit Group (TIER 1, TIER 2 & TIER 3) Counseling \$150 per 60-minute unit/Professional Teacher/Staff Development: \$150 per 60-minute unit/On Call Crisis Intervention & Debriefing: \$50 per 30-minute unit School-Wide Assembly Intervention: \$150 per 60-minute unit- Total amount will be based on the students in need. Source of Funds: ESSER III
- P. Approval to contract with Hope Institute to provide services to assist educators with the best practices for developing good character in students. Hope Institute will provide Hope Academy for five schools within the school system for the 2022-2023 school year. Hope Academy consists of six professional learning sessions, collaboration on a school implementation plan, a starter library of character resources, peer networking among Alabama school leaders, facilitator consulting, and one Professional Learning Unit (PLU) or clock hours for educators who follow the required guidelines., Cost: \$20,000.00 (\$4,000.00/school), Source of Funds: ESSER III
- Q. Approval of Digital Persistence for network support from September 2022 May 2023, Cost: \$100.00/hr., Maximum 10 hours/week, not to exceed \$50,000.00, Source of Funds: Local Funds or E-rate
