Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2024-25 School Description and Mission Statement

Harvest High School is a continuation and alternative school established in July of 2013. Harvest High serves the rural community of Ripon. The City of Ripon is home to over 17,300 residents, and is located 70 miles south of Sacramento and approximately 90 miles east of San Francisco. It is the most southeasterly town in the agriculturally rich San Joaquin County. The region is semi-rural and increasing in population. The community is primarily residential and farming, and it prides itself on its small town atmosphere. What once was a small farming community, is comprised of local and national businesses as well as large agrarian areas. Ripon High School is one of two high schools in the Ripon Unified School District and is fed by five K-8 schools. Moderate growth in the area is expected to impact the school, increasing enrollment and diversity. The current

enrollment of 15 students represents increasingly diverse ethnic and socio-economic groups with a wide range of language skills and academic abilities. 46.67% of the student population is white, 40% Hispanic, 13.34% multi-ethnic, and 0% Black.
