Superintendent's Report

Dr. Sullivan reported the electric bill was down this month from last year \$336.56. Our High School Cheerleaders had a strong finish at State Competition. The Board voted to table the UV-Sanitizing HVAC Bids to the next month's Board meeting. The Board approved that our District is not to send contact trace information to the Health Department according to Missouri Attorney General's letter as pertaining to COVID-19. The Board approved to amend the East Carter Re-Opening Plan and to strike the line "Contact tracing will be conducted through the East Carter Health Office in conjunction with the Carter County Health Department" and to add to the line that states "Quarantine directives from the Health Department will be logged and followed accordingly for positive cases of COVID-19. The Board took no action on the Local ECC Health Report COVID-19 numbers and the PAT to ECSE Transition. The Board approved to Let Bids for 3 buses. The Board

approved the Annual Secretary of the Board (ASBR) Balance Letter, Gifted Program Evaluation, Homeless Program Evaluation, Migrant Program Evaluation and the Safety and Emergency Preparedness Program Evaluation. The Board approved the transfer of \$50,000 from Fund 1 to Fund 4 and set the January Board Meeting for Tuesday, January 25, 2022 at 6:30 p.m.
