### NAVAJO/INDIAN PREFERENCE POLICY

In filling vacancies, the school shall give preference to qualified enrolled members of the Navajo Tribe in accordance with the provisions of the Navajo Sovereignty in Education Act of 2005. Verification of Navajo/Indian preference must be submitted with the application if claiming Navajo/Indian Preference.

### THE EMPLOYMENT IS SUBJECT TO BACKGROUND INVESTIGATION CLEARANCE PROCEDURES.

Section 231 of the Crime Control Act of 1990, Public Law 101-647 (codified in 42 United States Code § 13041), and Section 408 of the Miscellaneous Indian Legislation, Public Law 101-630 (codified in 25 United States Code § 3207) requires a criminal history records check as a condition of employment for positions that involve regular contact with or control over Indian children. This statement is notice that a national criminal record check will be conducted as a condition of employment. A favorable screening and a favorable background investigation is a condition of employment.

In performance of their respective tasks and duties all employees of To'Hajiilee Community School are expected to conform to the following:

### STATEMENT OF DUTIES:

- Supports the FACE program classroom in a supportive capacity to the FACE teacher, instructs small groups or individual students which are experiencing learning and/or language difficulties. Connect and support student's family to support student academic performance.
- The FACE Adult Services Coach will conduct initial interviews with enrolled adults for the purpose of determining needs assessment inventories and provide support in establishing career goals, investigating available educational and training opportunities. Employment preparation, resume-building, interviewing skills and job search outreach will be developed and provided. Individual and group sessions may be conducted for identifying and networking with community resources.

- The Adult Services Coach will meet with adults on a regular basis regarding career, educational, and cultural interests and /or other similar matters helping to explore alternative goals. Opportunities for participation in school events and activities will be made available to all enrolled adults.
- This position will participate and support the local FACE staff team with organizing, planning and implementing FACE Family Events and Recruiting efforts.
- Documentation of services delivered is entered daily into the online databased system. The FACE Adult Services Coach is recommended to have knowledge of the community and culture of the population served as well as basic technology and computer skills to utilize the databased system.

## MINIMUM EDUCATION AND EXPERIENCE REQUIREMENTS:

- 2 years of related experience
- Associate's Degree in Education
- A valid New Mexico driver's license is required.
- Must be able to successfully pass a Background and Character Investigation in compliance with the Indian Child Protection and Family Violence Prevention Act, Public Law 101.630.

## PHYSICAL REQUIREMENTS:

Good distant vision in one eye and ability to read without strain printed material the size of typewritten characters are required, glasses permitted. Ability to hear the conversational voice with or without a hearing aid is required. In most instances, an amputation of arm, hand, leg, or foot will not disqualify an applicant for appointment, although it may be necessary that this condition be compensated by use of satisfactory prosthesis. In addition, applicant must have mental and emotional stability.
