### **DESCRIPTION OF TARGET GROUP**

Debate/Forensics A (P) is the first semester of an upper level college preparatory elective course designed primarily for students who keep up on current events and who enjoy and wish to excel in public debate and/or public speaking. This five-unit course and Debate/Forensics B (P) may be repeated for a total of 20 units. During the second year, a more rigorous schedule will be maintained and students will be strongly encouraged to enter tournament speaking.

### **PURPOSE**

Debate/Forensics A (P) is the first semester of a one-year course that will focus on teaching students to effectively engage in competitive public speech and debate.

### PREREQUISITE

Achievement of a B or better grade in preceding English class.

### STANDARDS OF EXPECTED ACHIEVEMENT

- 1. Define the nature of leadership and demonstrate understanding of a basic leadership theory
- 2. Demonstrate understanding of leadership ethics and responsibility

## **DESCRIPTION OF TARGET GROUP**

Debate/Forensics B (P) is the second semester of a one-year course. It is an upper level college preparatory elective course designed primarily for students who have taken Debate/Forensics A (P) and who will continue tournament and community speaking. This five-unit course can be repeated for 20 units, provided that Debate/Forensics A (P) is also repeated. During the second year, a more rigorous schedule will be maintained and students will be strongly encouraged to enter tournament speaking.

### **PURPOSE**

Debate/Forensics B (P) is the second semester of a one-year course that will focus on competitive speech and debate and community speaking.

**PREREQUISITE** - Debate/Forensics A (P)
