### **Clara Bolen Annual Education Report (AER)**

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2018-19 educational progress for the Clara Bolen Elementary School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2018-19 school year, a Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

According to the data collected from the 2018/2019 MStep, Clara Bolen students outperformed the state average in all areas. The data also shows that there are academic gaps between students with learning disabilities and those without. We are actively using an MTSS Model to collect data through our universal screeners like STAR and DRA to help target low achieving students and provide them with the interventions necessary to help them achieve their learning goals. Increases to technology devices and software are an on-going process for all teachers in our building. Teachers have utilized a Reader's Workshop Model and Words Their Way component for ELA for the past 3 years. Professional development in the core subject areas and technology continues to help improve instruction and

interventions. With the third grade reading initiative, Clara Bolen is also implementing its third year of the LLI intervention resource in our Title I Program and we are continuing to provide after school, as well as summer school opportunities to lessen regression. These steps we are taking will not only help us improve student achievement and academic growth, but also to meet the enumerated proficiency targets established by the State.

State law requires that we also report additional information:

1. All pupils enrolled at Tawas Area School in grades Kindergarten through fourth grade are assigned to Clara Bolen Elementary School.
2. Clara Bolen Elementary School has completed its seventh year of a school wide Title I school improvement model during the 2019-2020 school year.
3. The District does not currently operate any specialized schools.
4. Clara Bolen Curriculum aligns to the National Common Core for Math and Language Arts, as well as implementing the new science and social studies standards rollout. Tawas Area School District is taking the necessary steps to stay current with these changes and provide resources and training so staff can deliver this content accurately to our students. This curriculum provides learning experiences in all areas of language arts (reading, writing, speaking, listening, spelling, and handwriting), mathematics, social studies, science, health, physical education, computer instruction, art, music, and other enrichment activities. We are continually updating our curriculum and instructional practices to meet the academic needs of our students.
