5. **We will** be available for consultations with parents after school and during Parent-Teacher Conferences.

**Parent Responsibilities:** **I will** ensure that my child completes all reading and math homework assignments and reviews it with him/her before signing.

1. **I will** attend at least 5 Title I Parent Engagement Meetings and 2 Parent-Teacher Conferences throughout the 2026-2027 school year.
2. **I will** communicate with my child's teachers via Class Dojo, phone call/Google meet, and/or text messages as it relates to my child's progress.
3. **I will** log on to the Parent Portal in Infinite Campus at least once per week and check to monitor my child's attendance, assignments, and grades. I will check and review my child's Wednesday Couriers for grades and other school information.
4. **I will** keep lines of communication open and collaborate with my child's teachers as it relates to student progress.
