Early Childhood Literacy and Mathematics Proficiency Plan

Purpose:

The district set a goal of at least 67% of all students meeting the state's "Meets" standard at third-grade reading on STAAR. The purpose of the Early Childhood Literacy and Mathematics Plan is to improve student performance in literacy and mathematics in prekindergarten through third grade.

Alvord ISD Curriculum:

The district offers full-day PreK to qualifying students. In PreK, AISD teachers use a state-approved direct instruction program for early literacy & math called Frog Street (120 minutes per day) and assess students using CLI Engage. This assessment covers rapid vocabulary, phonological awareness, mathematics, and social-emotional behaviors. In Kindergarten, AISD uses a direct instruction phonics program (Heggerty), McGraw Hill reading curriculum, and Go Math and assesses students using Texas Kindergarten Early Assessment (TX-KEA). This assessment covers vocabulary, listening comprehension, letter sounds, blending, spelling, math, science, and social and emotional behaviors. In First and Second grade the state assessment used for Early Childhood Literacy assessment is the TPRI. We also use Istation for a supplemental assessment in the areas of Literacy and Math for the Kindergarten, First, and Second grades. Third grade takes the State assessment STAAR for Reading and Math and for a supplemental academic program for Literacy and Math they use Exact Path.
