- 8. p. 25 Bus Transportation Students must be nine years or older to be dropped off without an adult.
- 9. p. 33 Added criteria for students to be able to participation in extracurricular (must attend school at least ½ day on performance and competition days).
- 10. p. 38 Added procedures regarding Artificial Intelligence (AI).
- 12. p. 45 Off Campus Behavior removed "and effects from those incidents are brought onto the school campus"
- 11.p. 43 Added #15 to dress code policy Face covering including the hair is prohibited without medical approval. (This is a safety issue).
- 12.p. 47 Add the Millbrook location to the ECAP letter and added both the Wetumpka and Millbrook ECAP contact numbers.
- 13.p. 50 Removed the paragraph about the SEL (Social Emotional Learning) module that students must complete when assigned to ECAP or ISS.
- 14.p. 50 Added due process procedures for students to the Code of Conduct section per the Alabama Legislative Act HB188.
- 15.p. 52- BBY Definance of Yondr Policy added new subcode for schools that have Yondr pouches.
- 16.p. 52 BC Possession and Use of Tobacco– removed matches and lighters and placed them under BI.
- 17.p. 53 BE Property Damage Increased the consequence for 7-12 grade and changed the amount from \$100 to \$200.
- 18.p. 54 BJ Directed or Non-Directed Use of Obscene or Profane Language or Gestures to a Student Added "to include undirected racial slurs."
- 19.p. 55 BM Unauthorized Absences Moved 4-6 grade consequences up to align with 7-12 grade which is 1st offense 3 days in ISS, 2nd offense is 5 days in ISS, and 3rd offense is 3 days in ECAP.
- 20.p. 57 BU Excessive Tardiness removed detention from 5-6 grade and replaced with in-school suspension which is what they have in middle school ISS (5th tardy is 1 day, 6th tardy is 3 days, 7th grade is 5 days)
- 21.p. 60 BY Computer Misuse Added a statement regarding artificial intelligence.
- 22. p. 70 DD Illegal Organization Rewrote the offense to say, "Any act by a group of students which threatens or intimates others. This includes, but is not limited to, enticing others to join a gang and physical contact."
- *Replaced the word "expulsion" with "ECAP placement pending administrative hearing."
- *Updated members included in the Administrative Hearings to Compliance Director, Curriculum Director, scribe, student, parent, and school administrator.

23. p. 45 Replace the sentence, "In all cases, the principal or his/her designated representative shall make an attempt (if circumstances allow) to notify the student's parent or legal guardian prior to the search." with the sentence, "The student's parent(s)/guardian(s) shall be notified by the principal or his/her designated representative of the search as soon as practicable under the circumstances.

24. p. 48 Added Taylor's Law

25. p. 67 - Changed CW to CX

26. p. 70 Added a new offense for CW which is as follows:

CW Distribution of Explicit Images - Students are not allowed to distribute, display, solicit, possess, or produce a sexually or pornographic explicit image of any individual, including sexually explicit images of a child. This prohibition applies whether or not the image is of an identifiable person nor whether the age of the individual can be determined. This prohibition includes images of known and unknown individuals and those generated by artificial intelligence.

K-3: 1st offense – Parent conference, administrative hearing, pending ECAP placement 2nd offense – Parent conference, administrative hearing, pending

4-12: 1st offense – ECAP (90 days), 2nd offense - ECAP placement pending administrative hearing
