The LEA will periodically evaluate the effectiveness of the activities carried out under this Area of Focus through mentee surveys and classroom data analysis.

Activity 1	Employ five part time teachers to mentor teachers that are new to the District. The five part-time mentors will be highly effective teachers in the areas of ELA or Mathematics. Mentors will focus on providing job embedded support through classroom observations, modeling, and feedback regarding instructional practice. Each part-time mentor will be work 40 hours @ \$22 per hour. The success of this activity will be determined by the number of new teachers that receive mentors that maintain successful employment with the district after one year. Mentors and mentees will meet during preplanning, during common planning, and after school.
Activity 2	Provide opportunities two times per year for students to take the ACT unreportable test at cost of \$48 per test, and the SAT unreportable test at a cost of \$8 per test. These tests can be used to meet the concordant score for students not passing the BEST/FSA ELA or Algebra I EOC for graduation purposes. The success of this acitivity will be based on the percentage of students meeting graduation requirements with a concordant score from the ACT/SAT unreportable test. Provide Write Score, a progress monitoring tool and supplemental instructional resource. This online solution provides rigorous writing assessments aligned to the state standards, and supplemental resources that enhance instruction in ELA. Success in the content area of text-based writing helps ensure success in meeting grade 10 ELA graduation requirements. The success of this activity will be measured by the percentage of students meeting BEST ELA standards during the intial and subsequent retake assessments.
Activity 3	Support salaries for teachers to participate in school leadership team meetings for the development of School Improvement Plans and ongoing progress monitoring. This activity is a continuation from the previous year and is being repeated due to the success achieved. Through successful school improvement activities, school improvement teams designed effective school improvement plans with measurable goals, and the action steps to achieve these goals. School grades have been used during previous years as the measure of success of this activity, grade level achievement as measured by BEST/NGSS/progress monitoring data to determine the effect.
