School Budget Information

School budget development is well underway in our communities. The SAU 7 budget was approved by the school board at the Board hearing on December 8. Much time was devoted to budget preparation and discussion with each school board. School district budgets have been presented to school boards and will be finalized later this month. We are scheduling public hearings and annual school meetings in February and March.

Community school budget information sharing will ensue after budgets are approved. This year, I have invited our principals to provide a school update during the Annual Meetings. We are also in the process of preparing school district publications of our Annual Reports.

School Board Fall Review

We held Board Policy Committee meetings in November and December. Each board will review procurement policies for subsequent adoption by our school boards.

During the November SAU 7 School Board meeting, The board endorsed the updated <u>SAU 7 Strategic</u> <u>Plan</u>. Our mission is to "prepare every SAU # 7 student for success in whatever path they choose. Our Vision continues, "We believe in a future where our entire school community - in commitment to the success of every student - will leverage the power of collaborative relationships to advance our education system and will serve as vital and supportive advocates for educational equity and opportunity."

Goal 1: All students reach maximum potential.

- a. Continue school improvement
- b. Broaden student voice
- c. Expand vocational offerings

Goal 2: Employ, retain, support a highly effective staff.

- a. Strengthen recruitment, retention of staff
- b. Challenge all learners
- c. Experiences are engaging and motivating
- Goal 3: Establish community relationships and partnerships
 - a. Collaborate with community partners to expand vocational course offerings
 - b. Provide more school to work
 - c. Increase parent involvement
 - d. Expand communication with the community

The additional adequacy aid from the legislature provided an opportunity for school boards to request permission from the voting citizens to allocate the additional funds to invest in school projects. Stewartstown Community School received approval to allocate \$84,270.00 to complete buildings and grounds projects. Colebrook received approval to implement a building expendable trust fund and allocate the additional adequacy funds of \$255,628.00 for the purpose of building expansion, including architectural and engineering services for a new addition.

As stated in the newly revised SAU 7 strategic plan, the need for more career and technical education in our region will be sought this year. The Colebrook School Board is seeking designation as a Career Technical Education Center and planning to implement 6 new CTE programs. An application is being submitted and we anticipate a response from the Commissioner of Education in January 2022. Many organizations and businesses have agreed to partner with us in this endeavor.
