There will be a special meeting of the New Milford Board of Education beginning at 10:00 AM on the morning of Thursday, April 7, 2022, for the purpose of conducting student disciplinary hearings. At the April 7, 2022 meeting, a panel of the Board, or a hearing officer serving on behalf of the Board, will entertain a motion to convene in executive session during which matters concerning the personal privacy of the student who is the subject of the hearing is likely to be discussed. Should the parents request that the hearing be held in public session, the Board panel or hearing officer will do so unless it is determined that an open session will implicate the protected confidentiality and personal privacy of other New Milford Public School students. The Board panel or hearing officer may take action when the panel or hearing officer returns to open session following the hearing.

Following the conclusion of the first hearing, but as part of the same special meeting, a second hearing will be held regarding a different student. Prior to the commencement of such second hearing, a panel of the Board, or a hearing officer serving on behalf of the Board, will entertain a motion to convene in executive session during which matters concerning the personal privacy of the student who is the subject of the hearing is likely to be discussed. Should the parents request that the hearing be held in public session, the Board panel or hearing officer will do so unless it is determined that an open session will implicate the protected confidentiality and personal privacy of other New Milford Public School students. The Board panel or hearing officer may take action when the panel or hearing officer returns to open session following the second hearing.

Following the conclusion of the second hearing, but as part of the same special meeting, a third hearing will be held regarding a different student. Prior to the commencement of such third hearing, a panel of the Board, or a hearing officer serving on behalf of the Board, will entertain a motion to convene in executive session during which matters concerning the personal privacy of the student who is the subject of the hearing is likely to

be discussed. Should the parents request that the hearing be held in public session, the Board panel or hearing officer will do so unless it is determined that an open session will implicate the protected confidentiality and personal privacy of other New Milford Public School students. The Board panel or hearing officer may take action when the panel or hearing officer returns to open session following the third hearing.

Prior to the commencement of such fourth hearing, a panel of the Board, or a hearing officer serving on behalf of the Board, will entertain a motion to convene in executive session during which matters concerning the personal privacy of the student who is the subject of the hearing is likely to be discussed. Should the parents request that the hearing be held in public session, the Board panel or hearing officer will do so unless it is determined that an open session will implicate the protected confidentiality and personal privacy of other New Milford Public School students. The Board panel or hearing officer may take action when the panel or hearing officer returns to open session following the fourth hearing.
