Our community service day was recently held with students helping out throughout the community painting, cleaning, and reading and playing games with seniors at the nursing home. Recently 10-12 grade students attended a "Buckle up Phone down" day at Smithton and our students showed excellent participation. Our Veterans Day breakfast was held on November 12th with area veterans and their families attending. FFA recently held their degree ceremony with 19 students receiving awards. NHS/NJHS held their induction ceremony this evening with 33 students being inducted. Winter HS sports have started. Varsity boys' and girls' basketball will participate in the Warsaw tournament December 1st.
