School Responsibilities

Old Shell Road Magnet School will:

- Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows: Old Shell Magnet School offers a high-quality arts integrated curriculum by highly qualified faculty and staff. We do this in a wellequipped facility that provides an effective learning environment with minimal disruptions and distractions. All teachers are trained through staff development opportunities that enable them to instruct students at various levels and in a variety of ways to meet academic challenges.
- Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held: A grade level parent meeting is held in August. Parent teacher conferences are held at least once a year and are additionally scheduled upon parent request. Teachers will review ACAP, iReady and any other grade level diagnostic data available.
- Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows: All classes are required to give mid-quarter reports. Teachers send home daily communications and behavior reports in student communication folders. All parents have access to Schoology where grades are entered weekly.
- Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows: Our staff will be available for conferencing during teacher planning time and teachers will also hold parent conferences before and after school to accommodate parent work schedules. Teachers will discuss communication methods at the start of the year.
- Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows: Parents will be given opportunities to participate in school activities, assemblies, performing art shows, and other special events. We welcome parent volunteers to assist with library and special events.
- Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand. Communication platforms include, but are not limited to, regular grade level newsletters, social media, school messenger, and website. Old Shell Road Magnet School will provide communication in the primary language of the family as requested.

Parent Responsibilities

- Monitoring amount of screen time & appropriate usage on all forms of digital devices and apps
