# <u>CHADWICK-MILLEDGEVILLE COMMUNITY UNIT DISTRICT #399</u> NOVEMBER 16, 2022 REGULAR BOARD MEETING

The Regular Meeting of the Chadwick-Milledgeville Community Unit School District #399 Board of Education was held at the Milledgeville School on Wednesday, November 16, 2022 at 7:00 p.m.

**AGENDA:** A motion was made by M. Bibler and seconded by M. Urish to approve the agenda. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, B. Smith, and M. Urish voting aye. No nays. Motion carried.

**CONSENT ITEMS:** A motion was made by A. Drinkall and seconded by M. Bibler to approve the following consent items as presented.

## **OLD BUSINESS**

**Fiscal 2022 Audit Report:** A motion was made by M. Urish and seconded by A. Drinkall to approve the Fiscal 2022 Audit Report. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, B. Smith, and M. Urish voting aye. No nays. Motion carried.

Mr. Kyle Polhill, CPA of Benning Group, presented this year's report. Overall, the report was positive with no significant findings.

# NOVEMBER 16, 2022 REGULAR BOARD MEETING, CONT.

**Bus Bids for Two Full-Sized Buses:** A motion was made by B. Smith and seconded by M. Urish to approve and accept bus bids for two 72-passenger, full-sized buses. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, B. Smith, and M. Urish voting aye. No nays. Motion carried.

Superintendent Schurman reported that the bus bid tabulation sheet was included in the packet. Midwest Transit, which sells International Buses, was the lowest bidder with a purchase price of \$132,319/bus and a five-year lease payment of \$29,898/bus. Midwest also offered \$44,500 for each of our trades (\$89,000 total). Buses will be delivered next July.

#### **NEW BUSINESS**

**Tax Levy:** A motion was made by B. Smith and seconded by P. Eubanks to approve adoption of a preliminary 2022 Tax Levy. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, B. Smith, and M. Urish voting aye. No nays. Motion carried.

Copies of the levy will be available in the Chadwick-Milledgeville CUSD #399 District Office for public review until December 19, 2022. The proposed levy increase is below 5% and does not require a Truth in Taxation Hearing. Superintendent Schurman said that he expects we will see an actual 2% increase in EAV.

**Press Board Policy Update Issue #110 First Reading:** This policy update includes revisions to the following policies: district operations, school fee waivers, school district elections, board member term of office, conflict of interest, school board organization, emergency/crisis procedures, threat assessment procedures, access to public records, food services, fiscal and business management, technology, employee ethics & conduct, workplace harassment, equal opportunity employment, grading and promotion, student records, attendance, truancy, curriculum and instruction, student health and behavior, five year reviews, and updates.

#### **CLOSED SESSION**

A motion was made by B. Smith and seconded by M. Urish to convene in closed session at 7:56 p.m. in order to consider information regarding the appointment, employment, compensation, discipline, performance, or dismissal of an employee or legal counsel for the public body and to consider student discipline. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, B. Smith, and M. Urish voting aye. No nays. Motion carried.

A motion was made by P. Eubanks and seconded by M. Bibler to reconvene into regular open session at 8:04 p.m. Voice vote showed 7 ayes and no nays. Motion carried.
