If you have questions about your immigration status, you should only talk to a qualified attorney or accredited representative. If you live in Minnesota, you may qualify for free legal help, but there may be a waiting list. Here are some options:

  - DACA RENEWALS: We urge those eligible to renew to do so. Call our intake line to schedule an appointment.
  - DETENTION INTAKE: If you are detained by Immigration and Customs Enforcement (ICE) or calling on behalf of someone in the custody of ICE, please call 651-641-1011 during the following hours to receive assistance:
    - Monday: 2 - 4 p.m.
    - Thursday: 1 - 3 p.m.
