The Brimfield Board of Education held its Regular meeting on Wednesday, January 17, 2024 at 7 p.m. in the High School Library. Board President Updyke called the meeting to order with the following members present: Snyder, Butterfield, Kappes, Bell, Blodgett, and Monk.

The Board welcomed Nick Vlahos; Nick had no comment on any matters at this time...

Butterfield motioned and Monk seconded to approve the minutes from:

Board President Updyke reported. Glad the students are back in school; it was nice to have a couple of "old fashioned" snow days!

Superintendent Jones reported. The recommendation-for the Activity Bus Lease Agenda item- is to go with MTE for two Activity Buses; it will be beneficial to lease both for 5 years as doing so will provide flexibility and we can claim 80% depreciation over that time. The tax [rate] will not increase with issuance of the working cash bonds. [Issuance of the bonds] will allow us to complete much needed projects; would like to schedule a Building & Grounds Meeting. In addition to any previously discussed projects, would like to fulfill any BGS needs during the full containment period during window replacement. An example letter was shared that he would like to have sent out regarding plans during inclement weather. A tentative calendar has been created; hoping to bring the [2024-2025 School Year] calendar for approval next month. This School District will be benefiting from a \$10,000 safety grant; Butterfield suggested that Mr. Jones inquire about window glazing.

Mrs. Steele reported on the High School. Updates were provided on the attendance rate and the 2024-2025 school year schedule. Adding in dual credit classes helps level out class sizes. The Board was briefed on class changes for next year- primarily Language Arts and Math. Some important dates / events were shared.

Mrs. Albritton reported on the Grade School. Updates were provided on: Winter benchmarking (the students are encouraged to give their full effort); K-4 ELA Committee (late April/early May target time to present a curriculum to the Board); January 3rd Institute Day events; IESA Scholar Attitude Award Change (candidate has to submit own application to IESA); BGS Book Blast (supported by the IPA, the goal is to get a book in each student's hands); PTO carnival; and the State Assessments. Information on sports was provided. There was mention of the basketball hoist system being in need of repair. Superintendent Jones added that with the 7th Grade State Volleyball taking place in March, there is a need to amend the calendar; would like to present the modified calendar next month. Updyke inquired about the hoist basketball system at BGS; Mr. Jones explained what we are looking for and that we are currently gathering information and pricing.

Blodgett motioned and Kappes seconded to Approve the FY24 SEAPCO Hiring Survey as presented. Superintendent Jones mentioned that this is a formality for SEAPCO- they must have this.
