Course Description:

Large Animal Science Technologies is an applied course in veterinary and animal science for students interested in learning more about becoming a veterinarian, vet tech, vet assistant, or pursuing a variety of scientific, health, or agriculture professions. This course covers the anatomy and physiological systems of different groups of large animals, as well as careers, leadership, and history of the industry. Upon completion of this course, proficient students will be prepared for success in the level-four Veterinary Science course and further postsecondary training.

Class Design

The three main parts of an Agriculture program are class/ lab activities, FFA, and SAE (Supervised Agriculture Experience). The classroom and lab are where students will learn and apply basic knowledge and concepts. FFA activities will provide opportunities to develop leadership skills, explore interests, compete in career development events if the student chooses to do so, and broaden horizons. The SAE allows students to take learning to the next level, take ownership, and perfect problem solving skills.

Students are required to carry out a SAE. This project is chosen by the student and must be related to agriculture. There will be more detailed information given on this at a later date.

Students will be in contact with live animals.

The student and his/her parents further discharge and hold harmless to the Franklin County, the Franklin County Board of Education, the Franklin Co High school and the Agriculture Department, and its officers, agents, servants, and employees from and against any and all claims, liabilities, losses, or damages arising from bodily injury or death of any persons and damage or loss of any property resulting or arising out of or in connection with the animal(s) the students will be working with.

Classroom Rules:

Consequences:

- All safety violations will result in loss of shop privileges for one week (an alternate assignment may be given)
