

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).






This chart shows the total general purpose revenue Vallecitos Elementary School District expects to receive in the coming year from all sources.

The total revenue projected for Vallecitos Elementary School District is \$2,928,027, of which \$2,246,089 is Local Control Funding Formula (LCFF), \$138,126 is other state funds, \$354,606 is local funds, and

\$189,206 is federal funds. Of the \$2,246,089 in LCFF Funds, \$630,508 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

This chart provides a quick summary of how much Vallecitos Elementary School District plans to spend for 2021-22. It shows how much of the total is tied to planned actions and services in the LCAP.

Vallecitos Elementary School District plans to spend \$3,043,865 for the 2021-22 school year. Of that amount, \$2,150,530 is tied to actions/services in the LCAP and \$893,335 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:



In 2021-22, Vallecitos Elementary School District is projecting it will receive \$630,508 based on the enrollment of foster youth, English learner, and low-income students.
