  - \*Parents may check their child's grades using Schoology.
- 4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:
  - \*Parents may request conferences, in addition to the two (2) conferences set up by the school.
  - \*Parents may also contact faculty and staff by telephone, note/letter, ClassDojo, or through the school's website.
- 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:
  - \*Parents may volunteer by providing a state issued identification card to sign in the front office and obtain a visitor's pass.
  - \*Collins-Rhodes' Partner in Education Liaison will provide parents with volunteer information and information about visiting classrooms.
- 6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practical, in a language that family members can understand.
- \*Communication folders will be provided for every child which will serve as parents' daily contact about homework, behavior, school newsletters, and classroom newsletter information.
