TITLE I AND POTTSVILLE SCHOOLS



 Title I... is a program designed to help improve the academic achievement of disadvantaged students.

TITLE I—FUNDS AND ACTIVITIES

- Our Title I funds enable us to have such things as:
- A Reading Recovery Program at Elementary
- Highly Qualified Paraprofessionals and/ or Reading Specialists to support instruction
- Parent and Family Engagement Activities
- Classroom and Library Books
- Technology
- After school tutoring-MG



TITLE I— PARENTS'/GUARDIANS' RIGHTS



- Under Title I, parents have the right to request information regarding the professional qualifications of the classroom teachers and paraprofessionals who instruct your child. If their child has been instructed by a non-highly qualified person for 4 consecutive weeks (letter addressed to parents of the student receiving Title I services).
 - Parents also have the right to ask for a meeting to discuss and formulate suggestions and to participate in decisions about the education of their children.

TITLE I-PARENTS' RIGHT TO KNOW

- Our Annual Report Card (on DESE website--shows how we compare to other districts)
- Individual Student Assessment Report (students and families will receive test results that will indicate a student's proficiency level on a state assessment)
- Disabled Parents/Guardians (right to ask for any auxiliary aid to help with parentschool communication);
 Sign Language Interpreter; Text in large print; and Materials in Braille.
- Written State Complaint Procedures (about curriculum-on DESE website)

TITLE I PARENT-SCHOOL COMPACT

• The parent-family-school compact outlines how parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents and families and the community in general will build and develop a partnership that will help children achieve the State's high standards.
