

Glen Ullin/Hebron Joint Board Meeting  
Wednesday, March 20<sup>th</sup>, 2019  
Hebron Public School Hebron ND, 6:00 pm

Present from Glen Ullin were Marie Bittner, Travis Thomas, Lisa Gerving, Matt Miller, Superintendent-John Barry, Principal-Pete Remboldt, and Business Manager-Tabi Schneider. Absent: Carrie Gerving, Shawn Dziuk, and Matt Kuhn. Present from Hebron were Lorie Unruh, Stacy Schmalenberger, Laken Wehri, Emily Coots, Dave Kraenzel, Bill McCone Superintendent-Myron Schaaf, Principal-Jen Hosmen and Business Manager-Paulette Elder. Absent: Daryl Schulte.

1. Call to Order- Roll Call: Lisa Gerving and Stacey Schmalenberger called the meeting to order at 6:06 pm.

2. Approval of the Agenda: Marie Bittner and Bill McCone made a motion, seconded by Matt Miller and Dave Kraenzel, to approve the agenda. Motion unanimously carried.

3. Coaches Salaries: Marie Bittner and Lori Unruh made a motion, seconded by Travis Thomas and Bill McCone, to approve to change coaching salary base for Varsity Boys Basketball, Varsity Girls Basketball and Volleyball to \$300 per week with a 3.5% increase to the base for JV, C squad, JH and Elementary coaches and put in place the tier system for years of experience being: Varsity-\$100/per year experience pay, JV \$75, JH and Elementary \$50. Current Varsity golf and track coaches will be grandfathered in at the current base with no increase and the tier system. If different head coaches for golf and track are hired they will then go to the \$300 per week pay schedule with the tier system for experience. Motion unanimously carried.

4. Practices and Games: Marie Bittner and Emily Coots made a motion, seconded by Matt Miller and Lori Unruh, to approve to have Boys Basketball games and practices in Hebron for the 2019-2020 season and the Girls Basketball games and practices in Glen Ullin for the 2019-2020 season with the exception of two games for each sport at the opposite court during the season for a two year trial period. Motion unanimously carried.

5. Parent's Night & Award Banquets: These activities will follow the # 4 above Practices and Games schedule and volleyball will rotate from year to year.

6. Travis Thomas and Bill McCone made a motion, seconded by Marie Bittner and Lorie Unruh, to approve to write a letter to the ND High School Activities Association to move to Region 5. Motion unanimously carried.

7. Travis Thomas presented information to both boards on basketball and volleyball machines. This item was tabled.

8. Adjournment: Meeting was adjourned at 7:30pm.
