Safety Presentation - Dan Mather, Plant Manager / Paul Collier, AP

Paul Collier updated the group on safety upgrades that have been put in place including regular District safety meetings/trainings, inter-agency coordination, active shooter training, full-time SRO, gate controls, buildings numbered, visitor check-in system with background checks, addition of more video cameras, and GPS monitoring for all school vehicles. For a complete list, contact Dr. Collier.

Dan Mather presented some statistics related to school emergencies.

- The last time a student died in a school fire was 1958.
- Since Columbine in 1999, there have been 231 school shootings, 304 fatalities (including perpetrators), and 485 injuries.

The ALICE process for an active shooter was reviewed. At the beginning of this semester, all teachers reminded students of the procedures and encouraged them to become familiar with their surroundings, not only at school, but in the community. Different scenarios require different responses. When possible, run away from the sound of gunshots. Emergency plans vary when the threat is on campus versus off campus. D. Mather shared details about a collaborative project his department has with Family Consumer Sciences to create shields to cover all classroom door windows. Parents should not come to the school when in a lockdown.

To date, there have been 49 reports via the Bully Button, an anonymous system to report unwanted bullying.

Discipline statistics for the year were shared. Defiance is the #1 offense, with fights and drug possession/use as # 2 and #3, respectively.

A map of the PV area with SMPD responses was shared. The most infractions are reckless driving and traffic violations.

It was noted that we have a very active security staff and the use of technology greatly assists us in monitoring the campus, not only in emergencies, but daily. The Comprehensive Safe Schools Plan is on file in the Principal's Office and approved as presented.

Understanding importance of attendance/Board meeting snapshots

Attendance reports for months 3 and 4 for this year were reviewed. PV currently has the best attendance rate. Funding for the school is based on average daily attendance (ADA). Student must attend one or more periods to be counted. Automated calls for absentees go out twice daily.

Independent Study hours have been changed to the school day instead of evenings to better meet the needs of students. ADA is based on work completed.
