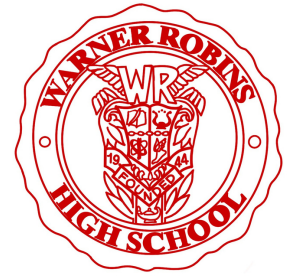

Georgia High School Graduation Requirements

English/ Language Arts	4 credits	One English class in each year of high school, to include Ninth Grade Literature, American Literature and two other English classes.		
Mathematics	4 credits	One math class in each year of high school, to include Algebra I, Geometry, Algebra II and one other math class.		
Science	4 credits	One science class in each year of high school, to include Biology, Physical Science or Physics, Environmental Science or Chemistry or Earth Science or an AP Science and one other science class.		
Social Studies	3 credits	Three social studies classes, to include ½ credit American Gov’t, World History, United States History and ½ credit Economics.		
Career, Technical and Agricultural Education	3 credits	Students must earn 3 credits, in any combination, from these three curriculum areas.		
Fine Arts		Students planning to attend a 4-year college or university immediately after high school must earn a minimum of 2 credits in a same foreign language.		
Foreign Language		Students who plan to continue a technical program of study at a technical college after high school are encouraged to take at least 3 credits in a single CTAE career pathway.		
Health and Physical Education	1 credit	½ credit Personal Fitness and ½ credit Health. Typically taken in the 9 th grade. A student taking 3 credits of JROTC will satisfy this requirement.		
Electives	4 credits (5 in Houston Co.)	Students planning to attend a 4-year college or university are encouraged to take at least 2 electives from academic curriculum areas.		
Total	23 credits (24 in Houston Co.)			
Promotion to the next grade is based upon credits earned. 10 th = 5 credits 11 th = 11 credits 12 th = 17 credits		EOC’s count 20% of the students’ final grade.	.	1 credit consists of two semesters; ½ a credit each. Credit is earned when a minimum passing grade is achieved. A semester lasts 18 weeks and consists of 90 hours of classroom instruction. Passing grade is 70 or above.
23 credits (24 in Houston Co.) must be earned to earn a high school diploma. A student has the opportunity to earn 28 credits in 4 years of high school during the school day.

College Prep Checklist

11th Grade

Student's 11th Grade Checklist

- Meet with your school counselor to make sure you are on track to graduate and meet all necessary requirements for graduation, academic rigor and college admissions.
- Continue to explore career options, how much education you'll need and the earning potential.
- Continue to research colleges and what you should look for to make sure you find a good fit.
- Go to a PROBE College Fair. If your school has a financial aid night, be sure to attend.
- Take the PSAT/NMSQT to qualify for scholarships and programs associated with the National Merit Scholarship Program.
- Register for and take exams like the SAT, SAT Subject Test and the ACT for college admission. Check for free test prep classes in your area.
- Start drafting essays to use for scholarships and college admissions applications.
- Search for scholarships you may be eligible for to help pay for college on GAfutures, as well as through your school counselor, community, family and friends.
- Consider completing college-level coursework through dual enrollment.

Parent's 11th Grade Checklist

- Talk to your child about the colleges they are considering and help clarify goals and priorities.
- As your child narrows the college search, check out the net price calculator and the true cost of attendance for each college. The comparison tool at consumerfinance.gov is another helpful resource to compare college costs and financial aid offers.
- Attend events like PROBE College Fairs and visit college campuses. Let your child do most of the talking.
- Review your financial situation and make sure you're planning for the cost of college appropriately. See the College Money Matter section on GAfutures.org for suggestions.
- Make sure your child is searching for local and national scholarships. Ask your employer whether any scholarships are available for the children of employees.

Vocabulary

GSFC: Georgia Student Finance Commission

When it comes to financial aid and planning for college, there are some key terms you should know to help you understand the process and make informed decisions.

- **529 Plan**: Tax-advantaged savings plan designed to encourage saving for future college expenses. Path2College is Georgia's 529 plan.
- **COA (Cost of Attendance)**: Total cost of attending a college or university, including tuition, room and board, books, lab fees, transportation and basic living expenses.
- **EFC (Expected Family Contribution)**: Number used to determine your eligibility for federal student financial aid. EFC is determined by the financial information you provide on your FAFSA, the application for federal student aid. Your EFC is reported to you on your Student Aid Report (SAR).
- **FAFSA (Free Application for Federal Student Aid)**: Filling out a FAFSA is the first step in the financial aid process. To be eligible to receive federal financial aid, a student must complete FAFSA.
- **FSA ID**: Provides access to Federal Student Aid's online systems and can serve as your legal signature. You must have a FSA ID to complete the FAFSA.
- **Grant**: Money given to students for their education that does not typically have to be repaid. Often based on need, grants may come from federal or state programs, or sometimes from private charitable organizations.
- **HOPE GPA**: Your HOPE GPA determines if you are academically eligible for the HOPE or Zell Miller Scholarship. It includes only grades earned in core subjects-english, math, science, social studies, and foreign language. You can check your HOPE GAP beginning in 10th grade through your My GAfutures account.
- **Merit-based**: Financial aid based on academic, athletic or some other type of achievement.
- **Need-based**: Need-based financial aid is reserved for low-income students.
- **Pell Grant**: Federal program that provided need-based educational grants for low-income students. Pell Grants do not typically have to be repaid.
- **SAR (Student Aid Report)**: Your SAR summarizes the information entered on your FAFSA form and shows the amount of your EFC.

Dual Enrollment (DE) Checklist

For a complete description and details concerning the Dual Enrollment program, go to gafutures.org. Eligible students who choose to enroll in DE must complete the steps below and submit this completed checklist to their counselor.

Student responsibilities:

1. _____ Apply for admission to the college in which you wish to enroll. Pay application fee (if applicable)
2. _____ Meet all admissions requirements of the college by taking/submitting any applicable assessments such as the ACT, SAT, Accuplacer, or college specific entrance exam. If applicable.
3. _____ Have your high school transcript sent to the college in which you wish to enroll.
4. _____ After you are accepted to the college of your choice, complete the online DE application each term at www.gafutures.org.
5. _____ Bring documentation of your college acceptance and this completed checklist to your counselor no later than deadlines provided below based on term attending DE.

Once all items above are complete, an appointment with the student/parent will be scheduled with the counselor prior to the start of the school year. Specific college course enrollment and high school scheduling will be finalized. Parents will complete final DE paperwork signing off on each college course requested.

High School Deadlines:

Summer 2023-

- Prior to May 12, 2023: Students schedule conferences with school counselor
 - Proof of acceptance from the college (Students complete check list items to get to this point)
 - Student brings college class schedule, which is needed to finalize school-level schedule.
- **FRIDAY, MAY 12, 2023** – All registration materials should be finalized including SAT/ACT test scores (if applicable). **FINAL DEADLINE.** NO students will be allowed to register for Summer Courses after this date.

Fall 2023-

- Prior to May 12, 2023: Students schedule conferences with school counselor
 - Proof of acceptance from the college (Students complete check list items to get to this point)
 - Student brings college class schedule, which is needed to finalize school-level schedule.
 - Counselor and student plan for full year scheduling, making a year commitment and plan.
- **FRIDAY, May 12, 2023** – All registration materials should be finalized including SAT/ACT test scores (if applicable). **FINAL DEADLINE.** NO students will be allowed to register for FALL Courses after this date.

Spring 2024–

- Prior to December 8, 2023: Students schedule conferences with school counselor (*Current and new DE students must complete this step)
 - Proof of acceptance from the college (Students complete check list items to get to this point)
 - Student brings college class schedule, which is needed to finalize school-level schedule.
- **Friday, December 8, 2023** – All registration materials should be finalized including SAT/ACT test scores. **FINAL DEADLINE.** NO students will be allowed to register for SPRING Courses after this date.

Things to consider:

- For every college class a student takes on the college campus, he/she will be released for two periods of the high school schedule.
- The high school does not have any control over college course offerings, availability or times on the college campus. Students that participate in DE classes on the college campus follow the college calendar.
- The high school does not provide transportation, materials, or academic assistance for courses taken at college.
- DE is a yearlong commitment unless the student does not meet Satisfactory Academic Progress requirements. Students attending college classes during specific periods of the school day 1st semester will be expected to continue to take classes during those periods 2nd semester. Each college has a Satisfactory Academic Progress requirement that must be met. For example, CGTC students must maintain a 2.0 GPA and pass 67% of college courses each semester. It is the student's responsibility to meet the requirements of the enrolling college's SAP to maintain funding.
- Each college class counts for 1.0 unit of credit on the high school transcript.
- Participation in DE is subject to deadlines imposed by participating colleges and the high school.
- The student participant and his/her parents or guardians acknowledge that dropping any classes before the end of the semester/quarter or not following program rules and regulations will result in a grade of a Z, removal from DE program, and may affect the student's high school graduation requirements.
- DE students must contact the high school counselor for approval before any course/schedule changes can be made during the semester/quarter.
- Colleges have attendance policies that students must adhere to that are different from the high school.
- The high school counselor advises on college courses needed to complete high school graduation requirements, not requirements for college degree student is seeking.
- Students participating in DE college courses should do so with the knowledge that the course work may be more rigorous and challenging than high school courses. Students are held to a higher degree of independent responsibility and accountability than in regular high school classes.
- Students who attend GMC will only receive DE money for 4 quarters per year. These 4 quarters include summer. Students could possibly run out of money for the spring quarter during 2nd semester. If this is the case, the student could possibly not be allowed to take college courses at GMC.
- The highest grade that will be posted to the HS transcript for a DE course is a 100.
- Students who take American Literature at the college are required to take the EOC at the high school. The EOC will count as 20% of the grade on the high school transcript. The EOC will not impact the college grade.
- Male Students must register for the Selective Service within 30 days of their 18 birthday to receive DE Funding.
- Students should be in constant contact with their high school counselor.
