

**Acceptable Use of the Internet, Other Computer Networks and Internet Safety**

The North Canaan Board of Education seeks to create high standards pertaining to online network use during school hours. Hence, the Board recognizes that the use of commercial Internet services and the Internet is a privilege and not a right.

**Telecommunications/Internet - Acceptable Use**

North Canaan Board of Education believes in the educational value of communications, the Internet, and electronic information services, and recognizes their potential to support its educational program, the curriculum and student learning. Resource sharing, communications, and innovation capabilities for both students and teachers have been increased with access to telecommunications and to the Internet. North Canaan Elementary School will make every effort to protect students and teachers from any misuses or abuses as a result of experience with an electronic information service. It is, therefore, imperative that members of the school community conduct themselves in a responsible, decent, ethical, and polite manner while using any network. **Guidelines for General Use**

It is important to recognize that with increased access to computers and people all over the world also comes the availability of controversial material that may not be considered of educational value in the context of the school setting. Further, the school district recognizes the importance of each individual's judgment regarding appropriate conduct in maintaining a quality resource system. While this policy does not attempt to articulate all required or proscribed behavior, it does seek to assist in such judgment by providing the following guidelines.

1. All use of the Internet, electronic services or any telecommunications network must support educational objectives or research.
2. Any electronic mail accounts shall be used only by the authorized owner of the account. Account owners are ultimately responsible for all activity under their account.
3. Any use of the district's computing resources or networks for illegal or inappropriate purposes accessing materials that are objectionable in a public school environment, or supporting such activities, is prohibited. Language that is deemed to be vulgar is also prohibited. Illegal activities shall be defined as a violation of the intended use of the service or network. Inappropriate use shall be defined as a violation of the intended use of the service or network. Objectionable is defined as materials that are identified as such by the rules and policies of the Board of Education that relate to curriculum materials and textbook adoption.
4. Any use of telecommunication opportunities for commercial purposes, financial gain, product advertisement, political lobbying, or attempt to disrupt the use of the services by others is prohibited.
5. The Board of Education has no control of the information on the Internet. Other sites accessible via the Internet may contain material that is illegal, defamatory, inaccurate, or

potentially offensive to some people.

6. Violations of the provisions stated in this policy may result in suspension or revocation of access privileges to the Internet, electronic services or district networks.

The Principal shall identify one administrator as the "Internet Administrator" who will have responsibility for implementing this policy, establishing procedures, and supervising access privileges.

To ensure the most acceptable standards will be invoked, supervising teachers will monitor network use and implement screening software to monitor Internet content. Students will follow the Code of Responsible Computer Use and security measures in our procedures.

We will comply with the law as referenced in The Children's Internet Protection Act (CIPA) as part of the Consolidated Appropriations Act, 2001.
