

Staff Development

Our staff development for the district focuses on Personalized Learning, Visible Learning, CCR standards, increasing vocabulary, literacy, numeracy, MTSS, and data analysis. It is important that we continue to heighten the professional growth of our teachers and administrators to develop the skills necessary for using research-based instructional strategies to strengthen our students' weaknesses and strengths.

Calhoun County Public Schools have established Tuesdays for staff development opportunities for the district. The first, second, and third Tuesdays are designated for school staff development and the fourth Tuesday is designated for the district.

Staff Development Opportunities

In Calhoun County Public Schools, staff development opportunities can be achieved in several ways:

- Staff development can be achieved by a group or individually.
- Staff development can be achieved by a consultant firm.
- Staff development can be achieved by a faculty or staff member.
- Staff development can be achieved in or out-of-district.

Inter-district (Ex. If a teacher desires to attend a staff development at a school, other than their own, in the district)	The teacher must request permission from their building level administrator and sign the agenda at the school that is providing the staff development.
Out-of-district	Faculty and staff must obtain initial permission from the building level administrator. (Follow district procedures)

Overview

Staff Development means a comprehensive, sustained, and intensive approach to improving teachers' and principals' effectiveness in raising student achievement. Calhoun County Public Schools have adopted the national staff development standards from Learning Forward formerly known as the National Staff Development Council. It is imperative that teachers and administrators are provided with staff development opportunities that are standards and research-based. Staff Development will expose teachers and administrators to a broader repertoire of effective strategies to use to adapt their practices to meet performance expectations and student learning needs.

Standards for Professional Learning

Professional learning standards provide a foundation upon which to design professional learning experiences at the district or school level that will assist educators in acquiring the necessary knowledge, skills and tools. The Standards for Professional Learning are as follows:

Learning Communities: Professional learning that increases educator effectiveness and results for all students occurs within learning communities committed to continuous improvement, collective responsibility and goal alignment.

Leadership: Professional learning that increases educator effectiveness and results for all students requires skillful leaders who develop capacity, advocate, and create support systems for professional learning.


Resources: Professional learning that increases educator effectiveness and results for all students requires prioritizing, monitoring, and coordinating resources for educator learning.

Data: Professional learning that increases educator effectiveness and results for all students uses a variety of resources, educators, and system data to plan, assess, and evaluate professional learning.

Learning Designs: Professional learning that increases educator effectiveness and results for all students integrates theories, research, and models of human learning to achieve its intended outcomes.

Implementation: Professional learning that increases educator effectiveness and results for all students applies research on change and sustains support for implementation of professional learning for long term change.

Outcomes: Professional learning that increases educator effectiveness and results for all students aligns its outcomes with educator performance and student curriculum standards.





ECTA DaSy Child Outcomes Summary

This course will provide the federal guidelines in regard to Child Outcome Summary (COS).

This course is designed to provide details surrounding the Child Outcome Summary (COS) process. It also will provide information on how programs can use the COS data to describe children's functioning in the three outcome areas listed:

- Children have positive social-emotional skills
- Children acquire and use knowledge and skills (including early language/communication and early literacy)
- Children use appropriate behaviors to meet their needs

In this course, the learner will gain information regarding the following surrounding the Child Outcome Summary Processes:

- The national and state processes in completing the Child Outcome Summary form.
- Details about each of the 3 Outcomes.
- How programs can use the COS to describe children's functioning in the three outcome areas.
- The importance of the "Team" approach in completing the COS to ensure an accurate rating for a student's ability levels
- Making concise ratings based on the data.
- The evidence needed to document those decisions and why documentation is important to the COS process.
- Utilizing the 7-Point Scale and the Decision Tree to support ratings on the COS.
- How the team should determine a COS rating at program exit.
- Knowledge surrounding the South Carolina COS processes.

With good information about child outcomes, professionals at all levels are better positioned for sound decision-making and program improvement.






