Goals

- to recognize those students who, on the basis of academic grades and performance, merit special note for past and current accomplishment in Latin
- to encourage those students to further their abilities within the discipline of Latin; and to encourage members to use their talents to serve others
- to extend their English vocabulary by learning English derivatives from Latin vocabulary
- to demonstrate knowledge of social customs of the Roman Empire
- to demonstrate knowledge of classical myths and legends
- to identify significant contributions of classical culture to Western civilizations in the arts, literature, music, science, and politics

Eligibility Requirements

- 1. Completed Latin II
- 2. Achieved a minimum GPA of 3.3 in Latin (based on final end-of-course grades)
- 3. Meets Fuqua School's minimum standard for overall GPA (not on academic probation)
- 4. Committed no serious behavior violation (level III or higher) throughout the previous academic year nor behaved in a manner that resulted in behavior probation

Application Process

- 1. Complete and submit The Latin Honor Society of Fuqua School application to the sponsor of the society.
- 2. Submit a minimum of a two paragraph (minimum of 7 sentences per paragraph) report on a famous building in Ancient Rome. You will need to be able to describe the functions of the building, events that occurred there, and other facts which may be of interest. Possible buildings are the Colosseum, Roman Baths, Pantheon, Parthenon, or the Cirus Maximus. Be sure to site your sources.
- 3. Submit a minimum of a two paragraph (minimum of 7 sentences per paragraph) report on an emperor and write about their life as a leader in Ancient Rome. Possible emperors are Caligula, Marcus Aurelius, Diocletian, Hannibal, Nero, Claudius, Caracalla, Trajan, or Hadrian. Be sure to site your sources.
- ***Students who meet all eligibility requirements and successfully complete all application requirements as determined by the Latin Advisory Committee shall be elected into membership.

Membership Retention

Students who fall below the standards that formed the basis for their selection as members shall be warned in writing by the society's Advisory Committee Chair and given a reasonable amount of time to correct the deficiency, except in the case of the flagrant violation of school rules or the law, in which case a warning will be waived. If the deficiency is not corrected, membership will be terminated.
