He corrected a few mistakes, and he answered some other questions. And with the answers I received, I don't feel that there is any ethics violations. To further go ahead, it says: If the suspected or alleged violation is disputed, Which I'm not saying it's disputed, I'm saying it's not. It says the board may initiate an investigation by an affirmative vote of a majority of members elected or appointed and serving on the board. So, according to this policy, we would have a

motion to conder or to continue with the ethics violation. So, what I'm looking for is a motion to continue with our investigation.

Veal moved to continue with the ethics violations investigation, supported by Porter. Discussion held. Roll call vote: Hart- yes, Chaskey-no, Palmer-no, Veal-yes, Porter-yes, Rieger-no. Kowalski- recused. Motion failed.

Porter requested that a formal ethical violation is looked into, correct (by Vice President Chaskey regarding President Rieger).

Chaskey moved to keep Thrun on (reinstate) and then, at the next meeting, set up some guidelines or boundaries. After him being here, there was a lot of things that were answered that had been, I will err on the nice side and say miscommunication. So, I believe that they can be useful with their wealth and knowledge, but there needs to be some more transparency, supported by Hart. Discussion held. Roll call vote: Palmer-no, Porter-yes, Kowalski-no, Hart-yes, Veal-yes, Chaskey-yes, Rieger-yes. Motion carried.
