# Coffee County Schools Title I Programs

## Title I is a federally funded program under the Every Student Succeeds Act

**Purpose:** To help low-achieving students meet the state's challenging academic content and performance standards. The Title I program offers a variety of services which may include: additional teachers and support staff, extra time for instruction, a variety of teaching methods and materials, smaller classes and additional training for staff.

**Qualifications:** Schools qualify for funds based on economic need. All schools in Coffee County are Schoolwide Programs.

### **School-wide Requirements:**

- Comprehensive needs assessment: The school must identify areas of greatest need
- School-wide reform strategies to include those that:
  - Strengthen the core academic program
  - Increase the amount and quality of learning time
  - Meet the needs of underserved populations
  - Address needs of all, but particularly low-achieving students
- Instruction by highly qualified teachers
- Professional learning for teachers
- Parent involvement strategies

## *Destination Graduation For College, Career, and Life*

**Status:** There are two schools in Coffee County identified as Additional Targeted Support and Improvement according to criteria determined by the Georgia Department of Education.

### **Parents Have the Right to Know**

- **Whether the student's teacher---**
  - has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction;
  - is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived; and
  - is teaching in the field of discipline of the certification of the teacher.
- **Whether the child is provided services by paraprofessionals and, if so, their qualifications.**
