**Moencopi Day School** will be participating in the **School Breakfast Program and/or National School Lunch Program.** As part of this program, Moencopi Day School will offer healthy meals every school day at NO COST to the students due to the implementation of the Community Eligibility Provision for the school year 2023-2024. Students will be able to participate in these meals programs without having to pay a fee or submit a household application.

Qualifications for children to receive free or reduced-price meals include belonging to a household whose income is at or below the Federal Income Eligibility Guidelines, belonging to a household that receives public assistance, or if the child is homeless, migrant, runaway, foster, or participates in a Head Start or even starts pre-kindergarten program.

In accordance with federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, this institution is prohibited from discriminating on the basis of race, color, national origin, sex (including gender identity and sexual orientation), disability, age, or reprisal or retaliation for prior civil rights activity.
