A MESSAGE FROM THE DIRECTOR



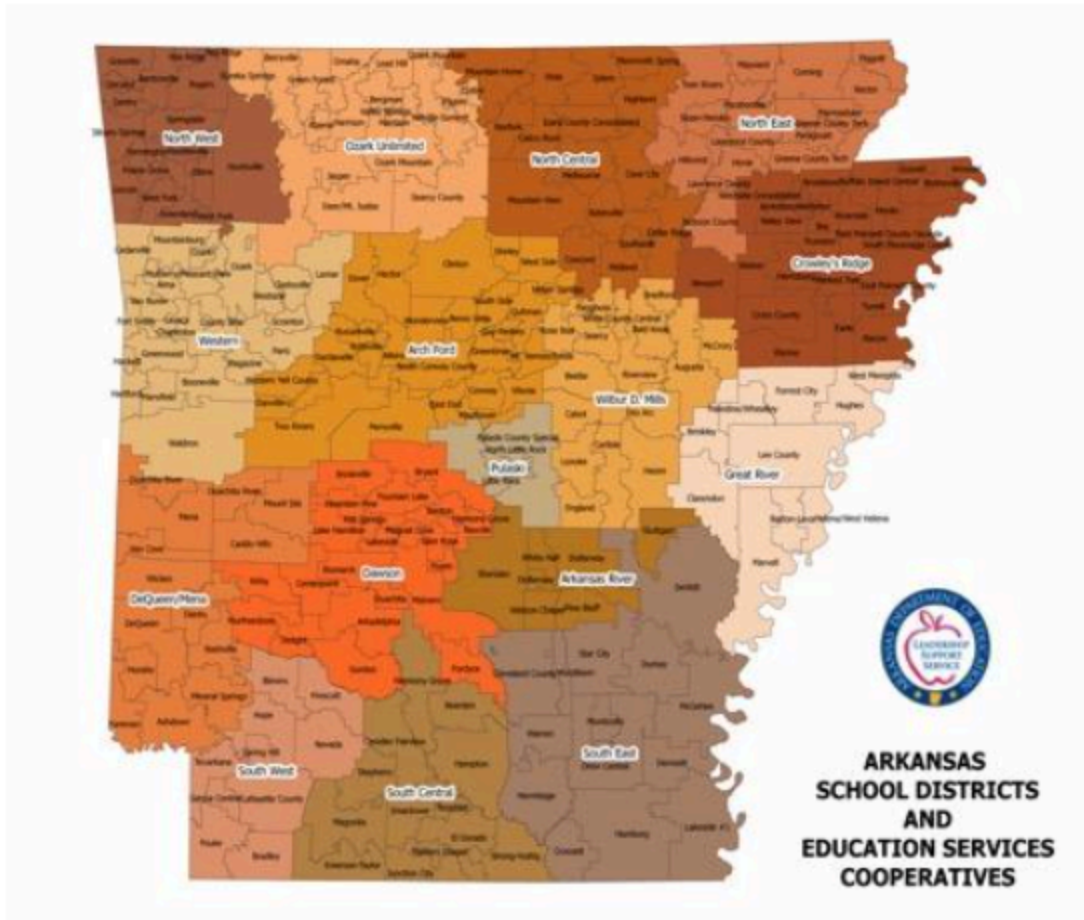
This report of activities for 2023-2024 was prepared by the staff to provide insight into each of the programs provided by SWAEC for our members and partners. School district personnel, school board members, area legislators, and State Department of Education personnel will be provided information on services furnished to our member schools during fiscal year 2024.

The Southwest Arkansas Education Service Cooperative (SWAEC) is made up of nine school districts in rural southwest Arkansas. The counties we serve include Hempstead, Lafayette, Miller, and Nevada. We serve approximately 11,000 students and 900 public school teachers and administrators. The Co-op offices are located on the campus of the University of Arkansas Hope-Texarkana (UAHT). Our current facility opened in August 2010 through a partnership with SWAEC, UAHT, the City of Hope and the US Department of Agriculture, Rural Development Program.

SWAEC has worked to form partnerships with the Arkansas Department of Education and higher education for the purpose of benefiting our districts. Some of our services include: preschool programs for 3-5 year olds; special education services including education examiner, vision and behavior support; content specialist in math, literacy, science, and technology; career and technical assistance; gifted/talented services; support for novice teachers; bulk purchasing and printing services; professional development; and early childhood behavior assistance. We are actively involved with Henderson State University, Southern Arkansas University, and UAHT. We also work with several community coalitions, such as United Way, Kiwanis and Southwest AR Arts Council, to improve education for our children in southwest Arkansas.

We are pleased to share this annual report. The following reports and program summaries will provide insight to the vast array of programs and services provided to our member schools. We look forward to our continued partnership with our member districts as we serve students and educators in the evolving work of Pre K - 12 education.

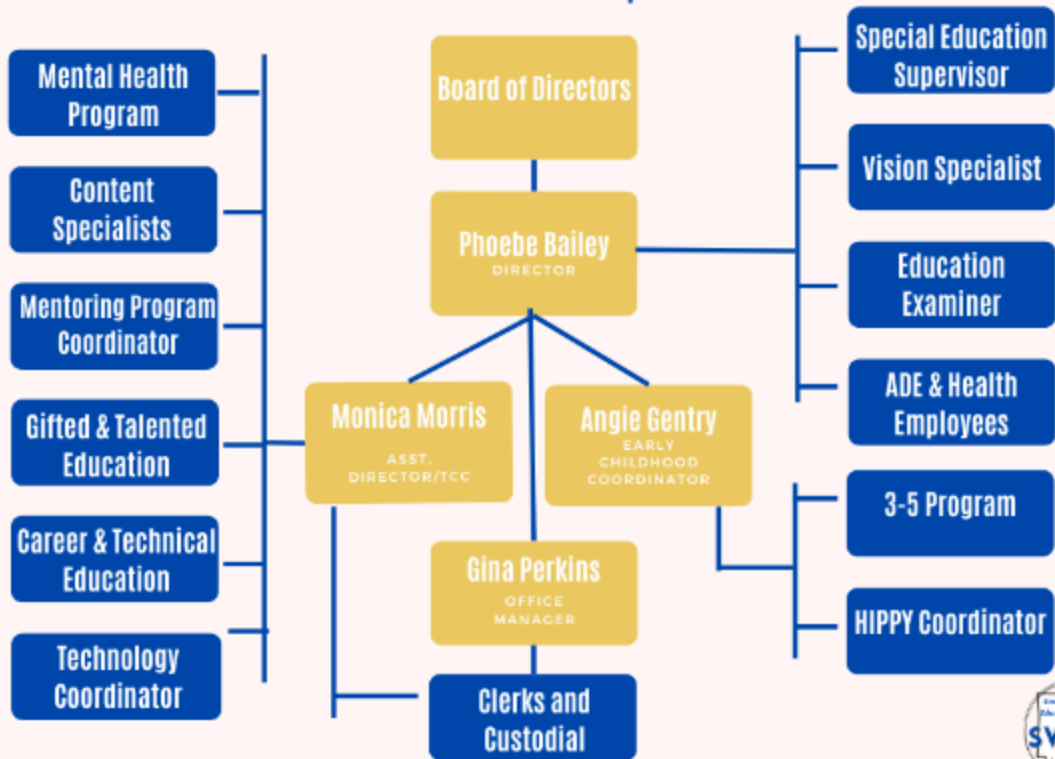

* SWAEC is a strong component of the department's alternate teaching program. We run the fiscal side for four sites and host our own year 1 and year 2 APPEL program. We graduated 14 teachers this April!

* SWAEC has worked with the AR School Board Association and APSRC to provide training specifically for the boards of SWAEC member districts. These meetings allow us to provide more targeted service for the needs of our area boards and allows them to save on travel as they do not have to go to Little Rock for their required hours.

Program Summaries

Cooperative Finance Overview

Arkansas Educational Funding: Cooperatives are funded from three primary sources: state, local, and federal.

State funds are awarded to Educational Service Cooperatives through targeted grants. The grant budgets and goals originate from the Arkansas Department of Elementary and Secondary Education. Grant funds are reimbursed by DESE after program-appropriate expenditures occur. The grants include targeted funds for reading specialists/coaches, math specialists, dyslexia specialist, science specialists, technology specialists, special education, curriculum training, and other grants as determined by DESE. The funds are carried over only by special permission from the Department of Education. DESE also provides \$408,000 annually to each cooperative for general operations. State funds represented 33.81% of all cooperative revenues in FY23 or \$62,905,805.

Local revenue is money that comes to a cooperative from local school districts by agreement. The services associated with these agreements include staff shared between districts, professional development services, special education testing, interest income, cooperative operations, repair services, and other special projects as determined by participating districts and the cooperative. Local funds accounted for 33.39% of cooperative revenue or \$62,123,261 in FY23.

Federal funds are governed by federal & state laws and rules for each program. They are reimbursed by DESE after program appropriate expenditures are made. Balances are regulated by federal rules. Federal Programs operated through cooperatives include the Migrant program, Arkansas Better Chance, the Perkins Program, and Special Education ages 3-5. Currently cooperatives have ARP ESSER funds that are associated with ABC, Early Childhood Special Education, and the Homeless program. For the fiscal year 2023, the cooperative Federal revenue total was \$59,473,048 or 31.97% of all FY23 revenue.

Total revenue for 22-23 was \$186,029,728. This includes the broad categories above, plus revenue of \$1,527,614. Additional revenue occurred in select cooperatives and included insurance claims, food service programs for students, and other revenue streams not common to the group.

Program Summary:

The ACT Prep Grant is designed to provide additional support to students in grades 7-12 in preparing for the ACT. Through this grant, all districts in Arkansas had the opportunity to opt-in for additional support for their students in taking the ACT. The grant included a subscription to On To College for high school students and prep sessions for any student taking the ACT.

Two hundred sixty-one school districts across the state opted-in to OnToCollege. This program can be used at the school level in multiple ways. Schools are able to use this resource as a class during the school day, an afterschool program or a summer bootcamp. Training was provided to each district.

Through this grant, cooperatives hosted ACT Prep sessions for student participation prior to their ACT test. Chad Cargill provided nine sessions for 688 students across the state. Each student spent three hours in a live session with Chad Cargill working on strategies for taking the ACT as well as content review.

Cantrell and Waller Preparatory (CW Prep) provided 24 sessions across the state to almost 2,000 students. In these sessions, students spent six hours studying content from the ACT. CW Prep also shares strategies with students when taking the test. Students leave the training with a one-year log-in to all the resources that were shared so they can use them to continue studying for the ACT.

Program Summary:

The Arkansas Professional Educator Pathway (ArPEP), is an affordable two-year, work-based, alternative certification program that is administered by the Division of Elementary and Secondary Education. Enrollment in this program allows a candidate with a bachelor's degree or higher to be licensed and employed as a classroom teacher while completing the necessary requirements for a Standard Arkansas Teaching License. ArPEP's goal is to prepare day-one-ready teachers to meet the growing demand of the teacher pipeline in Arkansas. The primary objective of ArPEP is to train future educators on how to:

- *build classroom communities
- *design effective lesson plans
- *implement evidence-based instructional strategies, and
- *use assessments to facilitate student learning

SWAEC supported 36 ArPEP students during the 2023-2024 school year from 7 of our 9 districts.

Goal:

Arkansas Better Chance (ABC) program is a high quality program that serves children, ages birth to five, with a variety of risk factors. However, the majority of availability is for three and four-year-old children. Providers are selected for their ability to offer a high-quality program. These abilities are assessed annually by early education professionals who evaluate each child and their ability for school readiness. The goal of Arkansas Better Chance classroom is to empower children with the skills needed to prepare them for kindergarten.

Program Summary:

ABC Classroom (Arkansas Better Chance) is a center-based school readiness program for families of 3, 4, and some 5-year-olds. ABC staff consists of a trained coordinator, lead teacher, and a paraprofessional. The staff administered the Brigance Developmental Screening and Assessment to each child. Parents receive two parent/teacher conferences throughout the school year to discuss their child's development. The staff is involved in collecting and documenting information on each child for the purpose of entering data into the State Data System Work Sampling. ABC classroom can serve a total of 20 children per year.

Major Highlights of the Year:

- * Every student received a preschool workbook, 2 children's books, crayons, scissors, paint, and pencils to take home for the summer to continue kindergarten readiness learning.
- * Nine students were identified and referred for services with Early Childhood 3-5 Special Education. The students received services to include developmental speech, PT, and OT.
- * Arkansas Children's Week was full of fun and learning activities.

The Arkansas Behavior Support Specialists (BSS) affiliated with the Arkansas Department of Elementary and Secondary education (DESE) - Office of Special Education lead the state-wide initiative, the BX3 (Behavior eXtreme 3 - Training, Coaching, Empowering) Project. This BX3 project is designed to build capacity by providing coaching to building-level behavior teams that are working to develop tiered systems of positive behavior supports for all students. BX3 assists building-level teams in developing and monitoring at least one SMART goal based on their assessment on the Tiered Fidelity Inventory (TFI). Additionally, the BX3 teams create and update an action plan focused on meeting their individualized SMART goal(s). The BSS offer at least six coaching sessions (one per month) for each BX3 team. Professional learning opportunities are offered as needed based on the SMART goal(s) and action plan.

Goal:

Enhanced Goal Statement for Career & Technical Education Annual Report:

The primary objective of Career & Technical Education is to effectively implement the directives outlined in the 2019 Perkins V Act. This federally funded initiative caters to both secondary and postsecondary career education programs, aiming to enhance accountability and underscore student accomplishments, thereby enriching opportunities for learners. Oversight of the Perkins funding is entrusted to the Arkansas Division of Career & Technical Education.

Additionally, a key aim is to equip students with the necessary skills and knowledge to excel in the workforce, postsecondary education, and military service. Through the analysis of data collected from various consortia, the state has established specific targets for the eight Perkins indicators. These targets are designed to drive academic achievement in areas such as literacy, science, and mathematics, as well as to improve 4-year and extended graduation rates, postsecondary placement, non-traditional participation, non-traditional program concentration, and the attainment of high-quality postsecondary credentials.

Program Summary:

The CTE Coordinator at the Southwest Arkansas Education Cooperative Perkins Consortium is tasked with crafting an annual Perkins application rooted in the Comprehensive Local Needs Assessment data, with a specific focus on consortia CTE Performance. This application delineates the allocation of funding to schools in our region based on indicator goals sanctioned by the Arkansas Department of Career & Technical Education and the SWAEC CLNA.

Moreover, the role entails organizing Stakeholder Meetings, conducting Comprehensive Local Needs Assessments, facilitating Start-up Applications, compiling Concentrator Reports, overseeing Placement and Certification Reports, offering Technical Assistance, coordinating CTE Enrichment Activities for Students, developing Consortia and School CTE Improvement Plans, and delivering professional development opportunities.

Major Highlights of the Year:

*Throughout the year, SWAEC CTE Coordinator continued work on the Miller & Hempstead County ACT Work Ready Community teams. ACT Work Ready Community teams help promote WorkKeys and NCRC certifications and recognition and recommendation of the NCRC to attract business and industry to the area to promote economic development and growth. All of the counties SWAEC serves (Hempstead, Miller, Nevada, and Lafayette) have met more than 90% of their goals to become ACT Work Ready Certified Communities. These teams will also implement a plan to recognize students with high scores on the NCRC through lapel pins and cords to be awarded at graduation.

*The CTE Coordinator welcomed guest presenter Micah Edwards for a CTE Teacher retention in-service dedicated to enhancing CTE Teachers' understanding of their role in the PLC Process.

*The CTE Coordinator hosted a New CTE Teacher In-service where new teachers were introduced to Perkins, CTSOs, DCTE, and certifications, among other information that is essential to becoming an effective CTE Teacher.

*The Career and Technical Education (CTE) Coordinator actively participated in monthly meetings hosted by the Southwest Arkansas Development Alliance to foster stronger Business and Industry Partnerships with our consortium schools. These meetings serve as a platform to enhance collaborations between consortium schools and local industries, facilitating opportunities such as internships, career exploration events, and career fairs.

*The SWAEC CTE Coordinator hosted PLCs for FCS, Agriculture, and Business teachers in the summers to support CTE teachers in their occupational areas and allow them to network with others in their content areas across Southwest AR.

*The Career and Technical Education (CTE) Coordinator collaborated with the DMESC and SCSC CTE Coordinators to showcase their partnership in organizing non-traditional student events to the AR Administrators during the Fall AACTE Conference in October. Following this, the team delivered another presentation at ACTE's Region IV Conference in New Mexico in April. They have now been extended an invitation to present their innovative partnership ideas at the national ACTE conference.

*The CTE Coordinator from SWAEC actively participated in multiple meetings with UAHT to enhance the alignment of secondary and post-secondary pathways, aiming to maximize opportunities for CTE students within the consortia.

*Enhancing CTE Programs and Opportunities in SWAEC Region The SWAEC CTE Perkins Consortia has successfully secured an impressive total of \$418,772.77 in additional funding through meticulously crafted grants penned by the CTE Coordinator. These grants, including the New CTE Program Start-up Grants, DCTE Non-Traditional Grant funding, and DCTE Innovation Grant funding, aim to bolster and enrich new CTE programs, eliminate obstacles for students from special populations, introduce students to local career opportunities, and impart valuable skills aligned with high-demand sectors in the local workforce through engaging student events.

*Highlights of the Funding Allocations In the recent allocation of New 2024-2025 CTE Program Start-Up Awards, Hope High School is set to receive \$30,307.77 for a new H3 Animal Systems Pathway, while Spring Hill High School will benefit from \$27,115.00 for a new H2 Business Finance Pathway. This brings the total for the 2024-2025 new CTE Program Start-up Awards for SWAEC schools to \$57,422.77. Notably, DCTE has modified its funding approach for start-ups in the current application cycle, with a specific focus on supporting H2 New CTE Pathways. Additionally, multiple schools have submitted applications for H3 Modernization grants during the months of May and June.

*Empowering Innovation and Skill Development A substantial amount of \$322,950 has been allocated towards DCTE Innovation Grants, with notable allocations including \$305,000 for the 'Girl Power to the Max: Next Level' initiative, \$5,200 for the SWAEC Special Populations Career Conference, and \$12,750 for the Hope High School Ag Transfr VR Headsets project. These funds have facilitated the provision of Computerized Numerical Control (CNC) BOSS Laser Engravers and CNC Plasma Cutters in every high school within the SWAEC Perkins Consortia. Students, particularly girls, received training on this equipment and participated in competitive events at both regional and state levels. Fouke High School achieved first place in CNC Metal at the state event, showcasing the impact of these grants in fostering skills development and career exploration for students, including those from special populations and the HHS AG program through Virtual Reality experiences.

*Promoting Non-Traditional Career Paths Collaborating with DMESC & SCSC CTE Coordinators, the CTE Coordinator successfully secured DCTE Non-Traditional funds amounting to \$38,400 for the Regional 'Be A Model, Break the Mold' Event. This event is specifically designed to introduce female students in grades 9-12 to career opportunities in manufacturing. Held at various educational institutions including UA Rich Mountain, UA Cossatot, SAU, and UA Hope/Texarkana, the event served as a platform to showcase the diverse programs offered by each organization, empowering students with insights into non-traditional career pathways.

*The Southwest Arkansas Regional CTE Showcase allowed Spring Hill CTE Teachers and students to present their programs and students in February to community and school stakeholders and school board members.

*The SWAEC Perkins V Comprehensive Local Needs Assessment Survey was released via Google Form in March 2021 and was revised in Spring of 2024 to gather information to guide interpretations of the upcoming Perkins V regulations set to be implemented for Perkins funds in July 2023. The CLNA is a live document that is updated often, as needs arise, and where stakeholders identify needs for our programs through a CLNA Survey.

Impact on Student Performance:

SWAEC Perkins Consortium participants saw an increase from 91.15% in the 2021-2022 school year to 92.86% in the 2022-2023 school year. Consortia Concentrators consistently met all the Perkins Indicator Targets set by the state for 2022-2023. SWAEC Concentrators scored in Reading/Language Arts 58.45%, exceeding the state target by 9.5%. In Math, Concentrators scored 51.02%, exceeding the target by 8.25%. Concentrators scored 59.73% in Science, exceeding the target by 10.83%. The 4-year graduation rate for SWAEC Concentrators was > 95% compared to 82.20% for Non-Concentrators. The 5-year graduation rate for Concentrators was > 95% compared to 75.47% for Non-Concentrators. Notably, post program placement increased from 72.19% to 78.74%. Industry certifications surged from 53.03% to 76.28%, exceeding the state target by a measurable 43%.

Goals:

The ADE DESE Office of Computer Science's established goals and associated tasks for computer science education implementation in Arkansas are divided into five categories:

1. Standards, Curriculum, and Pathways - Successful implementation of computer science education in Arkansas requires the development and periodic revision of a comprehensive and vertically articulated set of K-12 computer science curriculum standards and courses, the local creation of well-developed curriculum that supports student learning, proper alignment of the K-12 expectations and opportunities to industry needs, and appropriate K-20 pathway development for students seeking formal computer science education beyond high-school.

2. Educator Development and Training - Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to knowledgeable and informed computer science teachers. ADE, in collaboration with the Arkansas Educational Cooperatives and other partners, must support quality computer science educator development and training opportunities for all Arkansas Educators and Administrators.

3. Licensure - Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to licensed and endorsed computer science teachers. ADE will continue and further research and implement, when appropriate, flexible licensure pathways and practices, based on legislation and regulation.

4. Outreach and Promotion - Successful implementation of computer science education in Arkansas requires the active use of a broad range of mediums, digital tools, and human networks to properly communicate about the Arkansas Computer Science Education Initiative and respond to the needs and concerns of Arkansas students, educators, community members, and industry leaders.

5. Program Growth and Student Success - Successful implementation of computer science education in Arkansas requires encouraging broad school implementation, supporting lighthouse schools to expand their programs, increasing statewide teacher capacity, growing student interest, and increasing stakeholder interest and support using innovative programs and outreach initiatives.

Program Summary:

Education Service Cooperatives, in partnership with the Arkansas Department of Education, administers the Computer Science Support Program for grades K-12 (Support for Integrating the Embedded K-8 Standards; Middle School Introduction to Coding: Grades 5-8; and High School CS). In the interest of providing Arkansas educators with access to quality computer science (CS) professional development (PD), the Arkansas Department of Education (ADE) Office of Computer Science provided grants for ten Computer Science Specialists beginning in 2017. The computer science specialists each serve the CS PD needs state-wide for all ESCs, and Public School Districts. Assistance is provided to local school district educators through PD services including sessions (ADE developed & customized based on needs assessments) at the Cooperative as well as support on-site in living the mission and striving for the vision of Computer Science Instruction in Arkansas.

- * Continuing to develop and administer programs to locate, identify, and evaluate three to five -year-old children who are developmentally delayed.
- * Maintaining current information and liaison with other public and private agencies and individuals who provide services to this age population.
- * Through the Local Interagency Council (ICC) and Southwest Bridge Building Committee, collaboration of needs for the southwest are determined.
- * Continuing to develop and administer in-service training for personnel engaged in providing services to the developmentally delayed population, which includes daycares, Arkansas Better Chance (ABC), Head Start, and Day Service Centers in the area.
- * The purpose of the Behavior Interventionist position is to provide behavior support plans and intervention for students with severe behavior (ages 3-5), in all cooperative districts.

Program Summary:

The 3-5 Early Childhood Program takes responsibility for coordinating child find efforts within the region to develop and establish programs providing special education and related services to identified preschool aged children (3-5 years) with developmental delays; collaborates in planning with the LEAs and superintendents in their districts for implementing activities to ensure the identification of eligible children; provides services to such children in accordance with individual educational plans developed for children with the least restrictive environment being the primary concern. Early Childhood Behavior services are available through the cooperative. Behavior referral procedures are in place at the Southwest Arkansas Education Cooperative through the Arkansas Department of Education ECSpEd website. The Behavior Interventionist has a number of specific duties listed below:

1) working with parents and agencies when necessary; 2) writing behavior plans, performing observations, assessments, and referrals; 3) facilitating manifestation determination conferences; 4) collaborating with mental health providers; 5) conducting parent/teacher consultations; 6) assisting with the management of due process, crisis intervention, identification, etc.; 7) assisting with the management process related to autistic children; and 8) conducting in-service and staff training

For the 2023-2024 year, the Southwest Arkansas Education Cooperative Childhood 3-5 Program has the following data:

We started the 2023-2024 school year serving 141 students with disabilities. Total number of referrals were 155, and 24 did not qualify for services. At December 1, 2023, we were serving a total of 272 students. The following are the number of students served by each teacher: Leslie Dixon 49, Joyce Duenas 57, Jaslyn Richardson 59, Hannah Ward 54, Kelli Williamson 53. A total of 136 students transitioned to kindergarten, 119 with services and 17 without services. In therapy services we are serving 140: 135 Speech Therapy, 20 Occupational Therapy and 7 Physical Therapy. (Some students are receiving all three therapies.) We have 136 students returning to preschool in the fall for the 24-25 school year.

We provided early childhood behavior support services to 19 children for the 2023-2024 school year. These services included: training and classroom support for general education teachers, setting up and training children and classroom teachers in the use of visual supports and visual schedules, social-emotional support for children, and assisting special education teachers with writing behavior goals and functional behavior assessments.

Goal:

To provide consultation support services and direct orientation and mobility services to students who are blind or visually impaired, to their parents and to the school, center and related staff.

Program Description:

The Educational Vision Consultant/Orientation & Mobility Specialist at SWAEC served Arkansas's southwest, south-central, and southeast areas. The SWAEC Vision Consultant serves the counties of Polk, Scott, Pike, Montgomery, Columbia, Union, Ashley, Dallas, Clark, Chicot, Calhoun, Drew, Bradley, Ouachita, Nevada, Lafayette, Miller, Hempstead, Howard, Sevier, and Little River. The ESVI consultant provided required assessments (Learning Media Assessment, Functional Vision Assessment, Orientation & Mobility Assessments, Assistive Technology Evaluations), consultations, direct Orientation and Mobility instruction, and recommendations for adaptations and modifications to meet the needs of students who are blind or visually impaired, ages 3 through 21, in an educational program. The ESVI Consultant also loans adaptive equipment to students in school districts and provides large print/braille textbooks through our Instructional Resource Center. In addition, professional development opportunities are offered to parents, teachers, and related staff.

Major Highlights:

During 2023-24, the ESVI consultant continued to be housed at SWAEC. This enables continued communication between member districts, other counties and co-ops served, SWAEC, and LEA staff serving special populations. The ESVI consultant provided training to area preschools, school districts, TVI's, and students who are visually impaired across Arkansas. In addition to training, the ESVI consultant offered direct service to the school districts, consulted as needed, attended TEAM meetings/IEP meetings, etc, provided required LMA/FVA/O&M assessments, and direct instruction in orientation and mobility. Also, the ESVI consultant provided schools/parents/TVI's with needed equipment/materials/resources for in-school and home instruction. The ESVI consultant worked closely with teachers of the visually impaired serving the schools. The ESVI consultant teamed with Easterseals to work with multi-handicapped students, with the CAYSI Project to work with deafblind students, and with the Division of Services for the Blind to work with transition students. The ESVI consultant attended numerous training sessions to gain information and knowledge in skilled areas. Conferences/meetings attended that provided CEU credits included: Region 7 Meetings, ACC Fall Convening, LEA Academy, and assistive technology trainings. Conferences that provided required ACVREP credit hours needed for O&M certification: AR-AER Conference and Nanopac training . The ESVI consultant attended several staff meetings, consulted with ESVI consultants, and attended LEA meetings across the state in different co-op areas.

Purpose

Since 2004, the escWorks platform has been used across the state to house professional development hours required by Arkansas law to renew and retain teaching licenses and certifications. escWorks is an event management software that can schedule and track professional development offerings online. It then produces reports to quickly and clearly communicate services provided or taken over time. The software is made up of multiple online modules designed to schedule events, manage data, and most importantly, keep track of educators professional development hours. Before escWorks was purchased, there was not a consistent and logistical platform to track educator professional development in Arkansas.

Goal

By using escWorks, Arkansas school districts and administrators can access professional development history from any educator at any location across the state. This platform allows for school districts to easily verify employment history and trainings when they are interviewing and selecting high-quality educators for open positions.

Whether an educator has taught one year or twenty, they can use the platform to see their history of professional development and courses taken over their career. They can print transcripts and reports to keep in their personnel files or personal folders. Participants also have the ability to print a certificate of completion after a training.

Additionally, after each training session, a professional development evaluation survey is sent to all participants. The surveys are identical in the platform and allow participants to share feedback about trainings that our staff or guest presenters instruct. Our cooperative staff and specialists use the data from these surveys to improve instruction and grow in methodology. We measure the level of implementation of knowledge and skills participants had before and after attending the training. The comment section at the end of the survey is another tool we use to gain personal feedback from the teachers we support. It also allows us to closely inspect our practices and delivery methods.

Each Educational Cooperative assists their local school districts with escWorks in the following ways:

Hosting trainings for new and veteran teachers on how to use the platform.

Input trainings, meetings, and other events that participants can select to attend for yearly professional development.

Check attendance records with district administration to make sure professional development requirements were met.

Mark attendance in escWorks after a training is completed.

Answer Help Desk questions that come from users of escWorks.

Assist current and retired educators with obtaining records and reports.

Each of the fifteen Educational Service Cooperatives and the Arkansas Department of Education split the cost of this service each year. Approximately \$6,242.62 was paid by each entity for site maintenance and support FY23-24. Southeast Service Cooperative handles the renewal and purchase of this program each year. The total amount paid to escWorks to cover Region 4 (Arkansas) was \$99,881.93 FY 23-24.

Goal:

Serve as a liaison between ADE, Office of Gifted and Talented and Advanced Placement, district gifted/talented program coordinators, and parent and professional organizations. Provide technical assistance to meet the State Standards for Gifted and Talented Education and Advanced Placement. Promote gifted education through public awareness and advocacy.

Program Summary:

As the Gifted and Talented Specialist for SWAEC, my job revolves around making sure that the needs of the gifted learners in our districts are being met. This is only achievable by working with the fabulous GT educators across our nine districts and working hand-in-hand with DESE. On top of working with our GT educators who are responsible for meeting the needs of our gifted students in each district, it is also my responsibility to work with our regular education teachers to ensure that they are equipped with the tools necessary for helping our gifted students grow and blossom. Some of the services that I provide are: guiding GT Coordinators in the writing of the program application, pre-monitoring in preparation for monitoring of the program, and updating policies and procedures necessary for compliance. I hosted regular GT Advisory Council meetings to disseminate ADE updates, current trends and issues in gifted education, discuss practices and procedures for program compliance, share ideas and student activity events and dates, and keep abreast of the activities of the professional organizations for gifted and talented (Arkansans for Gifted and Talented Education and Arkansas Administrators of Gifted Education Association). Assisted member schools with various student activities such as Quiz Bowl, Vlog Competitions, Chess Tournaments, and even a Rubik's Cube Competition. I also provided professional development opportunities, including: Curriculum Differentiation; GT Scope and Sequence; Assessment for Identifying Gifted/Talented; Whole Group Enrichment; How to Better Meet the Needs of our Twice Exceptional Students; Classroom Management for Novice Teachers; and creative ways to include Arkansas History into the curriculum with my Eerie Arkansas sessions.

Major Highlights of the Year:

My main goal this year was to try to present multiple opportunities for our gifted learners to share their talents in numerous GT centered events. Beginning in September, I challenged 3rd-12th grade gifted and talented students in our school districts to compete in our fifth annual Vlog Competition. Over 60 gifted and talented students across our districts participated in this competition. This gave our GT students an opportunity to debate issues, explore their talents in using video, research, and to use their creative talents utilizing technology. The Vlog Competition Award Ceremony was held on December 14th, where we invited all students who participated to join us via Zoom and discuss what they learned from the competition, and we awarded the winners. Also this year, we held Senior High, Junior High, 7th grade, 5th-6th grade, and 3rd-4th grade Quiz Bowls for the students of our nine school districts. Along with our regular Quiz Bowl opportunities, the students in several of our districts reached out to me and requested that we have Quiz Bowls with a superhero theme and a Star Wars theme. During the month of November, we held our first SWAEC/SCSC Superhero Quiz Bowl. We also held our SWAEC/SCSC Star Wars Quiz Bowl during the month of April. The kids absolutely loved these enrichment opportunities. On 10/2/23, 11/6/23, 12/12/23, and 2/5/24, we were able to hold a face-to-face Chess Tournament for our Senior High through 3rd grade GT students to show off their awesome chess skills. We were also able to hold our Junior High and Elementary Chess Tournaments face-to-face. One of the biggest events that we provided for our GT students this year was the Rubik's Cube Competition that we held on 12/4/2023. We held a team event and an individual event for the students to show off their cube solving skills. It was amazing! Lastly, we had a great interest from GT teachers across our nine districts, as well as from around the state, to hold an Eerie Arkansas session with GT students. We held 12 virtual Eerie Arkansas sessions with GT students from all over the state (including our districts) where they were presented with information about the legend of The Fouke Monster. Their task, after doing some research on their own, was to come up with possible theories of what this strange phenomenon could be, and then, present their theories back to me. The information that they presented to me was absolutely awesome, and it turned out to be not only a great time for all that were attending, but an awesome learning experience for both the students and the educators.

Goal:

HIPPY is a family focused program that helps parents provide educational enrichment for their preschool children. The goal of HIPPY is to empower parents with the skills, tools, and confidence necessary to work with their children in the home. Parents will view themselves as their child's primary teacher and understand the critical role they play in their child's education.

Program Summary:

HIPPY (Home Instruction for Parents of Preschool Youngsters) is a home-based school readiness program for families of 3, 4, and some 5-year-olds. HIPPY staff consists of a trained coordinator and home-based educators. Parents receive weekly curriculum, along with books and supplies for 30 weeks. Home-based educators deliver the curriculum to the home each week and role play the activities with the parent. The parent teaches the curriculum to their child. HIPPY serves families from all ethnic and racial groups. We have served 75 HIPPY families for the 2023-2024 program year. The staff administered the Ages and Stages Developmental Screening and the Ages and Stages Social/Emotional Screening to each child. The staff is involved in collecting and documenting information on each child for the purpose of entering data into the state data system, COPA (Child Outcomes Planning and Assessment.)

Major Highlights of the Year:

Diamond Bank sponsored HIPPY family tickets to attend "Fairytale on Ice" at Hempstead Hall for exposure to performing arts. Families were given the opportunity to attend "Kid's Day at the Fair", sponsored by Four States Fair Ag Learning Center. Some of the activities included: mini rodeo, petting zoo, mobile dairy, Smokey the Bear as well as other educational presentations. We had 120 HIPPY family members attend our End of the Year group meeting. The families enjoyed a scavenger hunt, games and food. Families were also offered three other group meeting opportunities at various locations, including Hempstead County Library, Hope City Park and SWAEC.

Each HIPPY student received a backpack with preschool workbooks, crayons, books, and craft materials provided for families for the summer to enrich school readiness learning.

Impact on Student Performance:

Home Instruction for Parents of Preschool Youngsters (HIPPY) served 75 families for the 2023-2024 school year. HIPPY strengthens communities and families by empowering parents to actively prepare their children for success in school.

Program Summary:

The purpose of this grant is to provide professional development and support to K-12 literacy teachers in the cooperative area. Professional development and support is focused on the areas of curriculum, data analysis, science of reading and differentiated teacher support. It is the goal of the literacy specialist to enhance teacher awareness of current best practices and effective literacy instruction that follows the science of reading.

The literacy specialists work with assigned K-3 ELA teams to increase their knowledge of High Quality Instructional Materials.

Directed district support was provided in data analysis. Literacy specialists worked with districts to administer and analyze literacy screeners and diagnostic assessments. The data gathered was used to determine how to effectively group students for small group instruction. In addition to grouping, the data was used to develop appropriate tier 2 and 3 interventions.

Professional development was presented to help ensure that required teachers are developing a proficiency in the science of reading. The sessions include K-2 R.I.S.E. and 3-6 R.I.S.E., and all participants were provided on-site coaching support. Administrators were provided science of reading assessor training in the form of guided classroom walk-throughs and debriefing sessions to discuss the evidence that was documented. Specialists also provided support to align science of reading components with current TESS evaluations.

In a coordinated effort with DESE, the specialists provided direct support to three districts. The support included coaching, data analysis and HQIM implementation.

The purpose of the mathematics grant is to provide professional development and onsite support to administrators, instructional facilitators and K-12 mathematics teachers in the cooperative area. Skillfully implementing evidence-based practices through professional learning and job-embedded support, the Math Specialist works with partnering districts to support math teaching and learning. Partnering with the Arkansas Department of Education, SWAEC administers the Mathematics Program for grades K-12.

The Math Specialist currently supports teachers in four districts in AR Math QuEST (Quantitative Essentials for Students and Teachers). AR Math QuEST is a state-initiated professional development opportunity for exemplary teaching and learning based on NCTM's Effective Mathematics Teaching Practices and the Standards for Mathematical Practice. This two year professional training and support promotes best practices and the engagement of all students in reasoning and problem solving. The Math Specialist, along with a DESE State Specialist, supported 22 AR Math QuEST teachers in the co-op region and three Instructional Facilitators with 25 teachers fulfilling their two year commitment. The Math Specialist provided a minimum of two visits each semester, with most receiving three or more visits per semester. Means of support included assistance with planning lessons, observations and reflective feedback.

DESE implemented comprehensive coaching to improve teacher efficacy and to build instructional capacity. The Math Specialist attended 50+ hours of TNTP Coaching and Days 1 - 4 of Cognitive Coaching. For focused teacher support by the specialist, schools were chosen based on data to improve grade level learning. The Math Specialist provided this focused support to teachers in two districts with three teachers assigned direct support in three coaching cycles: late October - December, January - March, and March - May. Within these cycles, teachers chose an area for improvement from one of the following: Content Knowledge, Pedagogy, Classroom Management, Implementation of HQIM, or Implementation of RTI Strategies. The Math Specialist supported the teachers in setting goals, planning, observing, HQIM, and providing targeted feedback.

Using the new AR State Math Standards, the Math Specialist provided training to districts on standard implementation, math curriculum crosswalks, ATLAS, and the new Cambium Assessment. Along with other math specialists across the state, the Math Specialist was asked to assist in writing and aligning items for the summative assessment. The Math Specialist also assisted in writing the 5 R's for Active Student Engagement, which is the new AR state document for Student Math Practices.

The Math Specialist also attended HQPL, along with teachers from member districts, to develop the skillful use of HQIM and best practices in core instruction. These Content Coaching Academies were provided in three sessions each in the areas of elementary and secondary math. The Math Specialist assisted the presenter and provided support to K-12 teachers in SWAEC districts.

From June 2023 thru June 2024, the Math Specialist presented 25 sessions of professional development at SWAEC or in member districts for teachers and instructional facilitators. These sessions included topics on the new math standards and the Cambium assessment, ATLAS, AR Math QuEST, instructional routines, Building Thinking Classrooms, fluency, essential understandings, and math centers for the elementary classroom.

Goal:

Increase our students' access to mental health services in each of our districts.

Program Summary:

Our program collaborates with our schools to provide mental health evaluations and appropriate treatment (individual therapy, family therapy, group therapy, intervention, observation, treatment planning, whole class coping skills training) to any students that demonstrate need. All services are free to the students and their families.

Major Program Highlights:

In the 2023-2024 school year, our team has provided direct services to 258 campus or parent initiated referrals, group services were provided to 132 students in the school setting, and 32 staff members or parents were supported through our offering of the E-Therapy resource. Staff support and professional development were provided to all requesting districts. We were also able to offer the downloadable app, HelpMe, as a resource that provides mental health support to our students, families, and teachers 24 hours a day, 7 days a week.

Goal:

Objective 1: Provide training and support to novice teachers to increase teacher retention

SWAEC will implement a mentoring program that leads to improved student achievement by increasing effective teacher performance, establishing norms of professionalism, and providing training and support to novice teachers in order to increase teacher retention through in-class coaching, informal mentoring, virtual meetings, and video observations. We will use differentiated support to provide a high quality program that meets the needs of area schools, prepares novices to be day one ready, and encourages the development of teaching expertise at all levels of the mentoring system.

Objective 2: Establish norms of professionalism

SWAEC will help ensure that 100% of novices complete code of ethics training within one month of student-facing work.

Objective 3: Increase effective teacher performance, which will lead to improved student achievement

SWAEC will differentiate/scaffold support for novice teachers based on preparation program, (traditional, alternative), level of preparation (completer, enrolled, no program), and licensed/unlicensed (does this person need a plan for licensure?) through the development of teaching expertise and improving teaching performance and well-being of novices through the use of, but not limited to, buddy teachers, SWAEC Mentoring Support Team members, Praxis and Foundations of Reading assessments support, SWAEC content specialists support, and outside consultants as needed. SWAEC will use school and individual novice plans to differentiate support for novice progression towards earning a career educator license.

Objective 4: Provide licensure assessment support

SWAEC Mentoring will continue to support any teacher who needs to obtain an assessment score that will qualify them for licensure.

Program Summary:

The purpose of the Novice Teacher Mentoring Program is to support the professional growth of novice teachers in Southwest Arkansas. Novice teachers were provided with personalized support to meet individual needs through face-to-face meetings, on-site technical support, virtual coaching, on-line PLCs, etc.

This year, the mentoring program provided support for 223 individuals (81 year one, 77 year two, 53 year three, eight licensure support only, and four first time SpEd teachers). New novices received "The First-Year Teacher's Survival Guide," "The Classroom Management" book, and "The New Art and Science of Teaching" handbook. This year, we focused year two and year three novice training on allowing teachers to select from PD opportunities related to their individual PGP.

Each month, novice teachers received a Monthly Mentor's email with an inspirational message, along with tips for a successful school year, with topics that ranged from classroom management strategies to instruction and planning. The monthly message also contained information about current professional learning opportunities, webinars, and how to access support for Praxis and Foundation of Reading assessments. This information was also posted to the SWAEC Novice Teacher Website. The Mentoring Program Coordinator worked closely with SWAEC Content Specialists to help provide novice teachers Praxis and Foundations of Reading assessment support, content support, scheduling support, small group support, classroom management support, virtual tools support, etc.

During the year, teachers were given opportunities to meet virtually with the Mentoring Program Coordinator (MPC) concerning questions or ideas in which they needed assistance and any emotional support they may have needed. On-site visits were made to novice teachers for classroom management/procedures/routines support, and when areas of need in content were identified, the MPS worked with SWAEC specialists to help provide support. Monthly topics were also addressed in various formats: email, virtual Zooms, articles, etc. on ideas such as: Parent Teacher Conference advice, appropriate report comments, substitute folder ideas, etc.

This year, the mentoring program wrote district specific mentoring plans that included various ways to support teachers. Some plans included year 1 novice teachers attending quarterly training, while year 2 and year 3 teachers attended once a semester. The book "Supporting Beginning Teachers" was also used in a six-month book study to help support administrators, mentors, and district POCs as they support novice teachers.

All teachers, including those on alternative certification pathways, were given opportunities of Praxis support and Foundations of Reading support through checkout materials, 240Tutoring and individualized tutoring sessions (upon request). This information was shared through the Monthly Mentor's Message, and tutoring sessions were posted on the novice teacher website and DESE website. This year we also offered a Praxis reimbursement program for novice teachers who passed their assessment on the first try.

SWAEC received extra grant funding to provide for 12 teachers to attend training through NIET to receive their LEAD designation and coaching component to help meet the requirements of an experienced mentor teacher.

Information concerning novice teachers was given to building and district leaders at board meetings, the novice teacher website, and via Zoom meetings.

Impact on Student Performance:

From 2020-2021 data to 2023-2024 data, the Southwest Novice Network retention rate of teachers in the profession has increased from 94% to 97%.

Program Summary:

The Community Health Nurse Specialist is employed by Arkansas Department of Health and functions in a collaborative role with Southwest Arkansas Education Cooperative. Technical assistance is provided to the region's school district nurses and community coalitions through education and policy guidance and school health advocacy, with special focus on Best Practices for Nutrition, Physical Activity, Injury Prevention, and No-Tobacco. During the 2023-2024 school year, the CHNS continued to provide support services to local school districts and nurses.

CHNS activity related to the school setting includes advocating for the implementation of tobacco-free policies, best practices for tobacco prevention education, and best practices for promoting and implementing policies and programs for nutrition, physical activity, and emerging public health issues in the school-age child. The CHNS provides education for school nurses and wellness committees on health issues such as the consequences of tobacco use, injury prevention (intentional and unintentional), oral health, infant mortality, physical activity and nutrition. SWAEC CHNS is a CPR instructor and trains school staff, nurses, and community members in the American Heart Association's CPR/AED and First-Aid training programs. The CHNS assists schools in the implementation of laws that affect health and wellness in the school setting and offers assistance to schools on developing and maintaining wellness committees as required by Act 1220. The CHNS offers assistance with new tobacco laws, new or changing rules and regulations (kindergarten physical, immunizations, etc.), and trains school nurses on all mandatory screening (hearing, vision, BMI, & scoliosis).

Under the ADH, CHNSs are able to offer free NCPD (Nursing Continuing Professional Development) in certain workshops to school nurses to maintain their professional licenses. CHNSs survey school nurses and school staff to offer training and workshops that meet the needs of school health.

CHNSs offer programs and presentations to the students on school campuses in an assembly or classroom setting and are available as presenters and can assist in finding presenters to meet the schools' needs. The SWAEC CHNS has planned and will facilitate, and /or will present at several workshops this summer for school staff, wellness committees, and nurses, both at SWAEC and at other co-ops in the SW Region.

Southwest CHNSs (Dawson, DeQueen/Mena, South Central, and Southwest Co-op CHNSs) work closely together to meet the needs of Southwest Arkansas. CHNSs and CHPSs provide regional training to provide a level of consistency throughout the SW Region and cross borders to assist in other school districts to meet the needs of the school.

Activities of the CHNS related to the community setting include health fairs to promote health and wellness to the communities. Health fairs may also be on the school campus, in the community, or at a local job site. Health presentations are offered to community clubs (Lions Club, Rotary Club, minority clubs, etc.), worksites, and anyone else who requests these presentations. Here is a list of a few examples of presentations the SWAEC CHNS and CHPS can present in the community: CPR, First Aid, Youth Mental Health First Aid, Narcan Education and Training, Oral Health education and dental kits, Summer Safety, Assistance with District Wellness Committees, Colorectal Education, Tobacco/Vaping Education, Coordination with Schools to set up Mass School Flu clinics, STD/Reproductive Health, School Nurse Trainings, Stop the Bleed, etc. CHNSs attend several statewide meetings and trainings to stay abreast of school health topics and issues and collaborate at the state, regional, and local levels to provide continuity between the Arkansas Department of Education and the Arkansas Department of Health for the health of our students. CHNSs also work closely with Arkansas Children's Hospital, local hospitals, Arkansas Center for Health Improvement (ACHI), State Injury Prevention, Arkansas Cancer Association, Arkansas Prevention Resource, and State and local police. The SWAEC CHNS is a member of four county health coalitions. She attended state CHNS/CHPS meetings and other regional and local meetings. By partnering with local health unit administrators, she strives to meet the health needs of the community.

The major highlights of the 2023/2024 school year include reaching 987 students with vaping and/or tobacco prevention education during Red Ribbon Week, Oct 2023; providing 1217 dental kits to SWAEC students during Dental Health month in Feb 2024; provided a great Food Service PD workshop in Aug 2023 with 45 District Directors and staff in attendance; served as an active member on the SW Region ICDR (Infant Child Death Review Committee); became a member of the AR Oral Health Coalition, and participated in the Advisory Board meeting with SAU Nsg Dept.; partnered with SAU and other regional CHNS to provide training to SAU Nursing students; attended HealthCare Career Fairs at Tex College and Spring Hill HS to promote the nursing profession and support ADH.

Goal:

Our goal, through these programs, is to provide quality professional development training, primarily in the 13 critical areas, as outlined by the Arkansas Department of Education. The focus is to assist area schools in meeting the needs of their individual School Improvement Plans and to improve student achievement. These training sessions are funded through our Professional Development Consortium (PDC), in which seven of our nine districts participate. Participating districts contribute \$100 per certified staff member to the consortium. This funding helps support training sessions that cover a variety of related topics for which teachers and/or administrators have expressed a need. These funds are also instrumental in supporting several state initiatives, such as RISE, Science GPS and Teacher Evaluation. Districts not participating pay a per session fee.

Program Summary:

The Teacher Center Coordinator has a primary responsibility for planning and carrying out the Professional Development Program for member districts. The professional development programs are, in part, identified by the Teacher Center Committee as a priority among member districts. A wide variety of workshops and seminars are provided for teachers and administrators throughout the year, utilizing the expertise of regional, state and national consultants to train school personnel to help them develop both professionally and personally. Collaboration with the ADE and other agencies exists to provide professional development for specific groups such as: Special Education Teachers, Limited English Proficiency Teachers, Federal Coordinators, Gifted and Talented Teachers, Food Services, and Migrant Educators. Technology is supported through a variety of training sessions here at the Co-op and at the school sites.

Major Highlights of the Year:

Novice Teacher Mentoring training, School Board Member Training, RISE, and Math Quest. A separate PD activities report is included.

Summary

The purpose of this grant is to provide on site support and professional development to K - 12 teachers of science/STEM subjects in the SWAEC area. The scope of impact includes a variety of state, national, and local level services.

School Support

On site support included 106 school coaching visits, completing three coaching cycles.

Professional Development

The specialist presented, developed, or supported 16 professional development sessions from July 1, 2023 to June 30, 2024. This includes DESE provided sessions, specialist developed sessions, facilitated guest presenter sessions. Sessions were held on and off the SWAEC campus. The specialist provided professional development within the ArPEP system, specifically the Lesson Planning/HQIM session. The specialist often coordinated with a STEM Specialist at DESC to provide rural educators an opportunity to collaborate with other educators outside their usual area.

STEM Community Supports, Collaborations, and Outreach

The specialist served as a board member of the ISEF Regeneron Ouachita Mountains Regional Science and Engineering Fair (HS) and the ISEF Broadcom Masters Ouachita Mountains Regional Science and Engineering Fair (MS). Through the development of the Funomenal Arkansas series of professional development, partnership with the Arkansas Game and Fish Commission Rick Evans Grandview Prairie was continued. The specialist served as a judge supporting the CTE's Girl Power to the Max competition. The STEM specialist participated in planning the community-wide eclipse event at UAHT.

The specialist serves on the National Science Teaching Association's Rural Educators Advisory board, which advises the NSTA board on how the NSTA can better reach and support rural science educators across the nation.

Training Received

The specialist received 50+ hours of TNTP coaching training and completed the eight sessions of Cognitive Coaching training.

Goal:

The purpose of the Teacher Center is to provide services to our schools in three basic areas: staff development, curriculum development assistance, and educational materials. We meet those goals in a number of ways in both the Teacher Center and other areas of the Co-op. The Teacher Center Advisory Committee works closely with the Teacher Center staff and the Co-op Board of Directors. This open channel of communication assures that we continue to understand and meet the needs of educators we serve.

Program Summary:

The SWAEC Teacher Center provides a place for teachers, paraprofessionals, and administrators of all member districts to work on instructional materials, develop curriculum, and obtain instructional and media materials to meet the needs of their classroom. The instructional materials have been developed to coordinate with the Arkansas Standards. Instructional resources are available for teachers to use in the classroom. The primary focus of the instructional material is reading, math and language arts; however, we do have materials available for other subject areas. Technical assistance is available for educators, from laminating and supplies to curriculum designed to meet a specific need. One of the most popular services of the Teacher Center is the Ellison lettering machines and the numerous dies available for use. During the school year, the SWAEC makes Ellison cuts available to schools through six Ellison kits that travel to different buildings. Additionally, the Teacher Center provides teachers and administrators the use of a banner/poster maker, a binding machine, two laminators and copiers. Teachers use the Teacher Center on a regular basis for help and assistance through personal visits, phone calls, and school visits through the delivery system. The Center serves preschools and daycares, in addition to our member school districts. There are approximately 35 preschools and daycares that use the SWAEC Teacher Center services on a regular basis. Students from UAHT, Texas A&M-Texarkana and Henderson regularly use the SWAEC Teacher Center services. Private schools in the SWAEC service area also use the Teacher Center.

- *Conduct and facilitate meetings for district or school technology staff
- *Participate in co-op Technology Coordinator meetings and discussions as a liaison between districts and DESE
- *Work collaboratively with DESE to meet educational technology needs within the co-op and across the state as time and resources allow

Program Summary:

The purpose of this grant is to provide professional development for SWAEC staff and member district IT staff, teachers, administrators, and students, on topics like cybersecurity, internet safety, and other IT needs. The topics of these professional development sessions are aligned with state, DESE, and DIS directives and best practices.

School Support:

Member district support composed of meeting face-to-face with district technology staff and providing support on IT best practices, information about all state directives in IT governance and the new cybersecurity laws, and providing vendor learning opportunities for IT staff to stay on top of what is new in classroom/district technology.

The Technology Coordinator also provided over 150 hours of professional development for member district teachers, staff, and administrators on topics such as cybersecurity, classroom technology, classroom apps for teachers, internet safety, data privacy, and other IT best practices.

Cooperative Support:

The technology coordinator regularly provided professional development for cooperative staff on cybersecurity best practices with a focus on email awareness and student data privacy. Support also included making sure all staff IT needs were met and all staff had the tools needed to provide support for their students and districts they support.

Technology Coordinator maintained the cooperative network infrastructure which included cleaning up and modernizing portions of the critical infrastructure.

Major Projects:

One of the major projects completed this year was fully implementing the KnowBe4 learning platform for all staff at SWAEC. Through this platform, all SWAEC staff are building their toolkit on recognizing compromised emails and bad actor phishing attempts through monthly learning modules and test phishing campaigns designed to test what they have learned. This platform has been really successful so far, all staff are learning, and the overall state of email awareness at the cooperative is rapidly growing.

All SWAEC staff have also taken steps to protect the privacy of student, staff, visitor, and event attendee data by practicing recommended directives of encrypting this data. All staff have received professional development on how to send and receive encrypted emails and fully understand the importance of keeping this data safe and not exposed in clear text across email.

Another project included replacing the door access system for the cooperative. Site safety is a focus here at SWAEC and by modernizing the door access, the cooperative has greatly improved the safety posture of the main campus by allowing for access to the building to be managed remotely and the coming and goings of visitors to the cooperative being more thoroughly monitored.

escWorks:

The SWAEC Technology Coordinator is one of the state escWorks specialists and provides support to all Arkansas school districts for questions and ticket requests with escWorks. The Technology Coordinator also, when needed, has provided professional development sessions on teaching new district staff on how to use the escWorks platform.

StateRAMP:

The SWAEC Technology Coordinator led the cooperative into a partnership with a non-profit called StateRAMP. StateRAMP helps government, state, local, and educational institutions look into the third party vendors they contract with by making sure they are following state cybersecurity and data protection best practices, especially when it comes to student data. StateRAMP and their lawyers handle the heavy lifting, allowing SWAEC to know that the vendors they partner with that have the StateRAMP stamp of approval meet all of these criteria. SWAEC was the first Education Service Center in Arkansas to partner with them and several school districts are following the lead.

Professional Development:

The focus of professional development for the Technology Coordinator this year included Cybersecurity and AI technology.

The Technology Coordinator was able to earn several certifications on these topics and others including:

Program Name: Communities of Practice

Description:

Building Communities of Practice (CoP) is focused around Identifying Learning Loss and Accelerating Learning using High-Quality Instructional Materials (HQIM). DESE, in partnership with a national partner, will bring together groups of Arkansas system leaders (district and school teams). The Community of Practice will explore the leadership practices necessary to implement math and/or literacy instruction and learning supports that meet the moment, while staying focused on long-term recovery and acceleration goals.

The CoP includes a series of sessions, such as research and evidence-based strategies to address and plan for the acceleration of learning using HQIM.

Southwest chose to work with the Bailey Education Group to provide this service to our building leaders. We hosted three face to face training sessions at the cooperative. We also were able to provide 133.5 coaching days to our participating districts.

Program Name: Professional Learning Communities: Boardroom to Classroom

In support of the DESE's PLC Initiative, co-ops have been participating in the Boardroom to Classroom trainings monthly with Janel Keating from Solution Tree. As part of this process, Janel Keating guided educators in developing successful districtwide professional learning communities to ensure high levels of learning for every student. High-performing districts develop when collaborative teams at every level align their concepts, practices, and vocabulary. Aligning this work is a top-down, bottom-up cyclical process, starting with the district level and ending with collaborative teacher teams. This session provided district and school leaders with the tools and strategies needed to create a districtwide culture of continuous improvement. Co-ops are an integral part of this work and have been supporting districts involved in these sessions through Specialist support and working with administrators who are implementing PLC processes.

Goals and Description: The Framework for Teaching by Charlotte Danielson provides the foundation for the Arkansas Teacher Excellence and Support System (TESS). Southwest Arkansas Education Cooperative held the three hours Law and Process training(s). The Arkansas Department of Education provided training at each co-op for districts that opted in for premium services. Southwest Arkansas Education Cooperative scheduled additional sessions to extend the learning and to support administrators and teachers as they continue to implement TESS as the teacher evaluation system.

The goal for this event was to expose girls to non-traditional careers in manufacturing through hands-on activities hosted on post secondary campuses with manufacturing and agriculture programs.

Program Summary:

In the 2023-2024 academic year, SWAEC collaborated with SCSC and DMESC to organize the third annual "Be A Model, Break the Mold!" events throughout Southwest Arkansas. The cooperatives joined forces with UAHT's Hope and Texarkana Campuses, UA Cossatot, UA Rich Mountain, and SAU to offer high school girls the opportunity to explore non-traditional careers in manufacturing-related fields. Participants engaged in hands-on activities such as welding, industrial maintenance, industrial electrical work, CNC machining, diesel technology, powerplant and solar power management, business, IT, power tools, and vehicle maintenance. Meanwhile, boys had the chance to rotate through education, nursing, and funeral sciences workshops. All three Career and Technical Education (CTE) Coordinators were invited to present at the AACTE Conference in the fall and later at the Region IV ACTE Conference in April. This event was made possible through a DCTE Non-Traditional Grant of \$38,082.00, which was collaboratively written by all three CTE Coordinators and submitted by DMESC.

Goal:

The goal for this event was to expose girls to non-traditional careers in manufacturing through hands-on activities hosted on post secondary campuses with manufacturing and agriculture programs.

Program Summary:

In a collaborative effort, SWAEC partnered with SCSC, DMESC, Guy Fentor ESC, Crowley Ridge ESC, and Southeast ESC to host an empowering event called "Girl Power to the MAX!" These regional events aimed to provide girls with the opportunity to showcase their skills using CNC Plasma Cutting, CNC Wood, and CNC Lasering machines.

The event was made possible through a DCTE Innovation Grant totaling \$305,000, which was collectively written by six CTE Coordinators and submitted by DMESC. This grant funded the provision of Computerized Numerical Control (CNC) BOSS Laser Engravers and CNC Plasma Cutters in every high school within the SWAEC Perkins Consortia.

Participants utilized this equipment to compete in the SWAEC "Girl Power to the Max" Event, which was hosted by Ledwell in Texarkana. Teachers collaborated with the girls to prepare CNC Laser, CNC Wood, and CNC Cutting projects for the competition, with the chance to represent SWAEC at the statewide event on March 7, 2024. The state event will be held at the Saline County Career and Technical Center in Benton, AR.

Additionally, CTE Coordinators secured over \$10,000 in partnership donations for the state event and provided \$1500 in UAHT vouchers for girls who placed first at the SWAEC event. SWAEC is thrilled to announce that Fouke High School emerged as the 1st place winner in the state Girl Power event, specifically in the CNC Metal Cutting category.

CTE	SWAEC Perkins Consortium participants saw an increase from 91.15% in the 2021-2022 school year to 92.86% in the 2022-2023 school year. Consortia Concentrators consistently met all the Perkins Indicator Targets set by the state for 2022-2023. SWAEC Concentrators scored in Reading/Language Arts 58.45% exceeding the state target by 9.5%. In Math, Concentrators scored 51.02% exceeding the target by 8.25%. Concentrators scored 59.73% in Science exceeding the target by 10.83%. The 4-year graduation rate for SWAEC Concentrators was > 95% compared to 82.20% for Non-Concentrators. The 5-year graduation rate for Concentrators was > 95% compared to 75.47% for Non-Concentrators. Notably, Post Program Placement increased from 72.19% to 78.74%. Industry certifications surged from 53.03% to 76.28% exceeding the state target by a measurable 43%.
Virtual Arkansas	Virtual Arkansas Students had an 89% Pass Rate. 30,334 credits were earned. 8,132 college concurrent credit hours were earned. 2,353 students were enrolled in computer science courses. 2,006 students were enrolled in advanced placement courses.
Mental Health	In the 2023-2024 school year, our team has provided direct services to 258 campus or parent-initiated referrals, group services were provided to 132 students in the school setting, and 32 staff members or parents were supported through our offering of the E-Therapy resource.
Early Childhood/Special Education	Southwest Early Childhood Special Education Program has worked to address each of the three early childhood outcome areas, including social-emotional, knowledge and skills, and appropriate behaviors, as indicated on the annual performance report. The state targets for Social Emotional (both summary 1 and 2) as well as Knowledge and Skills summary 2 were above the state target, indicating substantial progress from the time the student entered the program through age six or exit from the program.
HIPPY	Home Instruction for Parents of Preschool Youngsters (HIPPY) served 75 families for the 2023-2024 school year. HIPPY strengthens communities and families by empowering parents to actively prepare their children for success in school.
Mentoring/Novice	From 2020-2021 data to 2023-2024 data, the Southwest Novice Network retention rate of teachers in the profession has increased from 94% to 97%.
Dyslexia	Total Number of Students Receiving Dyslexia Intervention Services in grades K-12 during the 2022-23 school year: 896 Southwest's dyslexia specialist coordinated Take Flight training. Districts have seen a positive impact on student performance after participating in the Take Flight training. Districts also see increased students exiting/testing out of dyslexia interventions.
Literacy, Math and Science	In the 2022-2023 school year, 100% of SWAEC's districts were classified as high usage (50 plus days of onsite support from SWAEC cooperative specialists per year). For the 2021-2022 school year, 38% of these schools received a letter grade of A, B, or C. For the 2022-2023 school year, this increased to 43% of schools receiving an A, B, or C letter grade.
