## IMPORTANT: PLEASE READ AND SIGN

- **Transportation is a privilege for students at Southwest Georgia STEM Charter School. Because we do not receive state funding for transportation, we only conduct pick up and drop off at identified locations. We will not be able to honor any requests for other transportation pick up or drop off locations.**
- If a parent/guardian is not at the bus location upon drop-off, the student(s) will remain on the bus and the school will contact the parent. Parents are expected to be at the bus stop as bringing a student back to the school is not in each bus driver's route at the end of the day.
- Students who are returned to the school 2 or more times will lose bus riding privileges for a designated amount of time.
- Please be considerate of the drop-off/pick-up locations for buses. The owners are courteous enough to allow us to use their properties for transportation locations. Do not litter or destroy property.
- Any student who misbehaves on the bus will get a warning (depending upon severity). If the behavior continues, the student may be suspended from riding the bus or permanently expelled from the bus.
- The school, nor land/business owners, are to be held liable for any injuries that occur at bus stop locations.
