



**School Parent and Family Engagement Policy**

In support of strengthening student academic achievement, **South Tattnall Middle School** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). ### **JOINTLY DEVELOPED**

**South Tattnall Middle School** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

### **ANNUAL TITLE I MEETING**

Parents are able to make suggestions to STMS at any time throughout the school year and through surveys on how funds are spent. STMS will provide a system that includes an orientation for 6<sup>th</sup> grade students & parents (July 2025). We will have open house for 7<sup>th</sup> and 8<sup>th</sup> grade students and parents (July 2025). After school begins, we will hold grade level nights for parents to attend (August 2025). Students entering 9<sup>th</sup> grade will be offered support with high school registration and transition (March 2026).

**South Tattnell Middle School** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and

- Each teacher provides parents with a course syllabus that includes information about the curriculum, standards that will be taught and assessed, and will provide results of assessments in a timely manner.
- GMAS EOG Individual Student Reports (ISRs) are written in a parent friendly language with descriptions and explanations of the assessment and student achievement
- Annual Title I Parent Meeting, Georgia Standards of Excellence, Georgia Milestones assessment, and Title I Part A requirements are discussed, as well as, other topics
- Open House – July 2025
- Grade Night – September 2025, February 2026, April 2026 – information will be shared about copyright policy, strategies for parents to help their child, etc.
- Family Engagement Events – (Literacy Night/Book Fair, GMAS Grade Night)
- Orientation/Transition Meetings
- Hold Response to Intervention (RtI) meetings for students requiring additional support with academics and/or behaviors.

- Hold 504 & IEP meetings to discuss progress of students with special needs.
- Hold Parent-Teacher conferences after each grading period; additional conferences as needed.
- STMS provides opportunities for the participation of parents with limited English proficiency and parents with disabilities. We have an ESOL teacher who is available to assist students and parents with limited English proficiency. Individual academic assessments, and the interpretation of those results, will be interpreted for parents in a language they can understand through the assistance of our ESOL specialists and translators available through the Tattnall County Board of Education. At this time, STMS has a Migrant specialist.
- Every effort is made to accommodate parents of students with disabilities.
- The Tattnall County School System policy for hospital homebound students is followed for homebound services. Parents requiring such assistance should contact the school for referral forms and assistance with the application process. Homebound services are provided through the central office of the Tattnall County School System.

### **BUILDING CAPACITY OF SCHOOL STAFF**

**South Tattnall Middle School** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Review faculty and staff handbook with teachers regarding professional expectations to establish a positive rapport with parents.
