Carrie Gerving expressed thanks on behalf of Jacobsen Memorial Hospital for taking part in Scrubs Camp.

- **4-D)** Secondary Principal/AD: Mr. Remboldt gave the board an update. Shawn Dziuk addressed school activities after six o'clock on Wednesdays.
- **4-E)** Superintendent/Elementary Principal: Mr. Barry gave an update to the board. Upcoming events: Field day, Kindergarten program, Muffins with mom.

5. UNFINISHED BUSINESS:

5-A) Negotiated Agreement: Shawn Dziuk gave information to the board. Carrie Gerving made a motion, seconded by, Travis Thomas to accept the negotiated agreement with the changes of an increase to base pay of \$1500, the addition of the retention bonus with one time retroactive pay and new teachers receiving one extra paid day to prepare for the school year and will be assigned a paid veteran teacher to assist them. Motion unanimously carried.

Travis Thomas made a motion, seconded by, Carrie Gerving to approve a salary increase for Mr. Remboldt in the amount of 3.5% of the base \$57,000 with the amount of increase being \$1,995.00 for the 2019-2020 school year and an increase for Mr. Barry in the amount of \$2,000 for the Superintendent position, \$500 for the Elementary Principal position for the 2019-2020 school year and to extend Mr. Barry's current contract by one additional year. Motion unanimously carried.

6. NEW BUSINESS:

- **6-A) Drivers Ed Contract:** Shawn Dziuk made a motion, seconded by, Matt Miller to approve the Driver's Ed Contract with Sara Reinbold for the upcoming summer. Motion unanimously carried.
- **6-B) Staffing for 2018-19:** Carrie Gerving moved, seconded by, Shawn Dziuk to approve to hire Stacey Geck as the Facilities Manager. Motion unanimously carried.

Travis Thomas moved, seconded by, Matt Kuhn to accept the resignation of Sarah Fox as Elementary Teacher as of May 17, 2019. Motion unanimously carried.

- **6-C) Co-op Meeting update:** Mr. Barry gave the board an update.
- 6-D) Projected 2019-20 Budget: Mr. Barry presented information.
- **6-E) Preschool Program for 2019-2020:** The board discussed a variety of options for 2019-2020 Preschool program. Mr. Barry will bring back revenue and expenses of the program.

6-F) Farm Ranch Management update: Matt Miller gave the board an update on the Adult Farm Management program.

6-G) Facilities:

- 1. Blaine Hertz presented information on the gym lighting project with dimmers. Carrie Gerving moved, seconded by, Marie Bittner to approve the bid with the dimmers on the gym lighting project for \$11,000. Motion unanimously carried.
- 2. Mr. Barry presented the board with information on summer projects. After discussion the board agreed to put the lawn tractor and the bus 6 out on bids.
- **6-H) Enrollment Report:** Kindergarten-10; Elementary-64; 7-8 grades-23; 9-12 grades-42. (139 Total K to 12)
- 7. Miscellaneous: Nothing was discussed at this time.
- **8. Adjournment:** Matt Kuhn motioned to adjourn the meeting, seconded by, Matt Miller at 10:10 pm. Motion unanimously carried.
