The meeting was called to order by the Chair, Mrs. Barbara McKenzie.

Rev. W. C. Henryhand, Board Vice-Chair, was absent from the meeting, but will be sworn-in at a later date.

Public Comment

Mrs. Mary Wallace, a Williamsburg County School District Parent, addressed the Board in support of a Special Needs teacher at the Magnet School. She asked the Board to allow her to remain in the district, because she is an excellent teacher, who works well with her child.

Approval of Minutes

A motion was made by Mr. James Darby and seconded by Rev. Norman Gamble to approve the minutes from the November 17, 2011, and November 30, 2011, Called Board Meetings; and the November 21, 2011, Policy Committee and Regular Board Meetings. The motion to approve the minutes was carried unanimously, (5-0). The Chair did not vote.

The Chair did not vote.

B. WCSD Proposed Calendar for the 2012-2013 School Year

A motion was made by Rev. Norman Gamble and seconded by Mr. Charles Garner to approve the administration's recommendation to adopt the 2012-2013 School Term Calendar.

Rev. Gamble asked about furlough days, and Dr. Jefferson-Barnes indicated that furlough days were not being recommended at time.

Ms. Bartelle asked if the ½ days were deleted, and why. Dr. Jefferson-Barnes responded that the calendar had been discussed with the principals, and there were no objections to the document as developed for Board approval.

Mr. Lee wanted to know the number of days required by the state for staff development; and the Superintendent told him ten days.

The motion to approve the calendar was carried unanimously, (5-0). The Chair did not note.

C. Hemingway High School Football Team Named Division 1A State Runners-Up in Football 2011-2012

The Hemingway High School Varsity Football Team earned the title of Division 1A State Runners-Up in Football 2011-2012. Team members, coaches, and school administrators were recognized by members of the Board with Certificates of Recognition and a plaque.

D. Finance

Expenditures and Revenues

Ms. Christine Green provided the Revenue and Expenditure Statements. She informed Board Members that current expenditures for December totaled \$2,322,913.47, with current revenues totaling \$2,648.363.00. She then invited Mr. Del Brown, the district's auditor, to share the 2010-2011 Audit Report with the Board.

Audit Report

Mr. Brown stated that the district received a "Clean" report with only 3 deficiencies as opposed to 15 last year. The deficiencies were: 1. Preparation of the Financial Statement, 2. Proper filing of documentation on Drug and Alcohol testing for bus drivers, and 3. Personnel activity report for persons paid from various programs i.e. 80% Title 1, and 20% from the general fund.

Mr. Brown proceeded through the audit, allowing for questions and answers throughout the presentation. A concern was raised about the Drug and Alcohol testing deficiency; and it was suggested that a staff member be assigned to correct the finding, so that it does not continue to appear in the audit.

There was a discussion on the number of students leaving Williamsburg County to attend schools in surrounding counties, possible reasons, and strategies for retention. It was noted that the transitioning of students could be documented as far back as the 1960's.

The management letter included one finding (not significant) related to pupil funds account summary and recommendation on school testing. Mr. Brown said hopefully next year, there will be no deficiencies. He commended the superintendent and the district; and emphasized the great job being done by the finance department.

D. Curriculum and Instruction

Williamsburg County Magnet School of the Arts

Mr. Lee Roy Campbell presented the objectives and vision of the Magnet School to the Board. Some of which included, securing a drama teacher, providing staff development, and meeting AYP. He also spoke of the strategies that have been put in place to accomplish the objectives.

Mrs. Sarah Boyd informed Board Members that the Magnet School showcased all of its components, during a presentation in December. She stated that enrollment applications are online, and that auditions would begin on February 28, 2012. Mrs. Boyd also stated that school staff would be traveling to Windsor Hill in North Charleston on January 28, 2012, at 8:00 a. m.

Executive Session

A motion was made by Rev. Norman Gamble and seconded by Mr. James Darby that the Board convene in Executive Session to discuss items listed on the agenda.

The motion was carried unanimously, (5-0). The Chair did not vote. The Board convened in Executive Session at 7:48 p. m.

A motion was made by Ms. Norma Bartelle and seconded by Rev. Norman Gamble to accept: 1. the retirement of Ms. Virginia Capps and Mr. Grady Richardson; 2. the administration's recommendation to accept the resignations of Ms. Ruth Boykin, Ms. Cassandra Breland, Mr. Christopher Kauffman, Ms. Kristin

The Chairperson thanked the principals and administration, on behalf of all Board Members, for gifts presented to them in honor of National School Board Recognition Month.

A motion was made by Norman Gamble and seconded by Ms. Norma Bartelle that the meeting be adjourned. The motion was carried unanimously, (4-0). The Chair did not vote. The meeting was adjourned at 8:17 p. m.
