### **HOS Report – Year in Review – Alyssa Schwartz**

- Successfully completed CMES' triennial AMI Elementary consultation
- 5 staff halfway through the LETRS training (new science of reading requirements)
- Continued to support families in need and to utilize community resources to supplement school programming
  - Special Education program continues to grow: hired three new teacher-qualified staff and completed 14 initial evaluations
  - Numbers have more than doubled in last several years
- Looking forward to seeing multiple staff complete AMI training this summer

### **State of the School Presentation /year in review – committee chairs**

- Advancement Committee – *Rachel*
  - Transitioned the work of the Marketing Task Force to Advancement
  - Coordinated with Meg Haley to plan next steps
  - Advertised open enrollment in new community newsletters
  - Investigated Cornerstone "swag" and created a budget for needed items
  - Planning summer, fall community outreach
  - Creating a packet for Parent Community Reps
  - Investigated new fundraising options
- Equity Committee – *Sarah*
  - Held a steady membership consisting of parents, staff, and administrators

- Met monthly to shape the future of the committee, including identifying ways in which the committee can contribute to the Strategic Plan
  - Hosted March Parent Partnership event focused on literacy, watching the documentary *The Right to Read*, which outlines the case for literacy as a civil rights issue. Megan Riemer and Jess Goff lead a discussion of literacy at Cornerstone. 37 adults and 33 children in attendance
  - Issued a survey following the Parent Partnership event to gather information on why this particular event was so well attended.
  - Made a goal of identifying Continuing Education opportunities for staff, administrators, board members, and the greater community related to equity
- Finance Committee – *Carolyn*
    - Finished complete update of Finance Committee Charter, last done in 2011.
    - Developed process for submitting funding requests to Finance Committee for review and discussion before forwarding to the full Board.
    - Actively invested idle cash balances giving CMES a financial cushion and additional revenue.
    - Reviewing contract renewal for CMES’s outside accounting firm, as required by Charter - done every three years.
    - Regular monthly review, updating budget, etc
  - Governance Committee –*Julaine Roffers-Agarwal, Chair*
    - Recruited two new teacher Board members
    - Continued with three year policy review cycle
