DISCUSSION

No motions were made at this meeting. Dr. Zito reviewed House Bill 5047 that was signed into law on February 15, 2022, which ends the state mandate to wear masks in school on February 28, 2022. Masks will still be required on school buses per federal regulations. A survey of Connecticut school districts on masking shows 90% of districts opting for masks being optional. The CIAC will also remove the mask requirement for student-athletes, coaches and officials for all indoor and outdoor practices and competitions. The Reopening Committee members discussed this issue and made suggestions and recommendations to the full Board.
