# B. Skool Live update - Mr. Hamm

Mr. Hamm met with representatives from *Skool Live* this week and accepted our first check for \$1000. There were shipping delays, but we appear to be back on track. *Skool Live* is an electronic Kiosk. The Kiosk streams school information and announcements. This also allows for advertising opportunities; a revenue generating venture for the school district. There will be Kiosks on all of our campuses. There will be two at the high school, and one each at the junior high and elementary schools.

Dr. Livingston was told the monitoring equipment in the Greenhouse was relocated to another school.

# C. TVF Grants – Ms. Sharp

Ms. Sharp shared with board members the following grants that were approved at the TVF grant meeting earlier this week. Ms. Sharp said the meeting was fascinating, hearing from teachers and administrators regarding their grant requests. Some grant requests received full funding while others received, reduced or partial funding. A select few will be funded fully by the District.

EGJH STEAM Lab - \$4700 (full funding; Price Award winner)

TVHS Graphing Calculators - \$2250 (50% funding)

TVHS Screen Acting equipment - \$2200 (full funding)

ACES Virtual Reality Classroom - \$3000 (50% funding; full funding for program at one school)

TVES Mobile Learning equipment - \$1350 (partial funding)

EGJH/TVHS E-Library materials - \$10,000 (full funding)

TVHS Art Technology - \$1750 (partial funding)

ACES Special Ed Chromebooks - \$3600 (partial funding)

TVHS Marimba - \$500 (partial funding)

EGJH Music Microphones - deferred to alternate sources, e.g. PTG

TVES Butterfly/Hummingbird Garden - district will fund

TVHS CTE Film & TV equipment - district will fund

Ms. Sharp thanked the board members who were able to attend the event. Ms. Rosalik made a video for Dr. Price which was well done, well received and Ms. Sharp thanked Ms. Rosalik for volunteering to do this for us and for doing such a great job. Ms. Sharp also recognized and thanked Mr. Tom Broccolo and his students for providing great music for the event.

# Virtual Reality Education

Ms. Sharp updated board members about a meeting she and Mrs. Place attended. Ms. Paula Nasiatka was instrumental in setting the Virtual Reality Education meeting up. Mr. Bill Patterson is an engineer with Raytheon and president of a new non-profit called Advanced Technologies in Education developed to support and improve STEM education. This program is to help students connect with the community, tying businesses with education - helping students learn 21 Century skills so they can develop relationships and meaningful work. Through these community connections, internship opportunities become available. Ms. Svea Anderson just received grant funding through Tanque Verde Foundation for the Virtual Reality Classroom she will be piloting next year. There was discussion about the acronym, STEM verses STEAM, The thinking is that perhaps we should consider going with STEM with emphasis in the Arts, or go with STEM Plus, when communicating with the business community.

# Personnel / Hiring update

Ms. Sharp reported that recruiting is going well, offers are being made. She relayed a conversation she recently had with a teacher who is coming to us. This teacher received two offers, one from us and the other from a neighboring school district. Before

deciding which offer to accept, she toured the campuses; what tipped her to us was, our teachers appeared happy and the students talked to her – our campus seemed more relational. Mr. Neff asked if our adjusted salary schedule has helped, Kim said "yes, it has helped."

Enrollment update – Mr. Adam Hamm
 Mr. Hamm updated the board that both ACES and TVES are each up one student.

# • District Report Card – Mr. Adam Hamm

Mr. Hamm said we are on track and closely trending with last year. With the recent Budget revision, our percentage of spending is slightly up. He advised board members that in the report next month, they will see more budget capacity due to the revised budget.

Mr. Hamm announced the district received a Certificate of Achievement for Excellence in Financial Reporting. Mr. Hamm asked that the following statement be recorded in the minutes: The Government Finance Officers Association of the United States and Canada (GFOA) awarded a Certificate of Achievement for Excellent in Financing Reporting to Tanque Verde Unified School District for its comprehensive annual financial report for the fiscal year ended June 30, 2014. In order to be awarded a Certificated of Achievement, a government must publish earn easily readable and efficiently organized comprehensive annual financial report. This report must satisfy both generally accepted accounting principles and applicable legal requirements.

A Certificate of Achievement is valid for a period of one year only. We believe that our current comprehensive annual financial report continues to meet the Certificate of Achievement Program's requirements and we are submitting it to the GFOA to determine its eligibility for another certificate.

Mr. Hamm commended the business office staff: Ms. Stephanie Silva, Ms. Lori Stonum and Ms. Julie Seibert for their hard work; adding, "This award is possible because of their efforts." He also thanked and commended Ms. Trish McCollum for the SAIS reporting – she is a thorough researcher. He said after a 3 year struggle with AZ Dept. of Ed., due in large part to Ms. McCollum's diligence, the district received the \$30,000 we were initially denied.

Mr. Neff attended a Special County and City Town Hall meeting yesterday, May 13 at Udall Center. District 4 Supervisor Ray Carroll and Ward 2 Councilmember Paul Cunningham held the meeting; he said about 30 people were in attendance.

Mr. Hamm said he would look into it.
