Student Parking Regulations

All of the following rules will be strictly enforced:

1. Use of the parking lot is a privilege that can be revoked at the discretion of the school authority. Vehicles parked on school grounds are **subject to inspection** by authorized school personnel.
2. Vehicles should be locked with no valuables left inside. The school **district assumes no responsibility** for private property.
3. Speed at all times while on school property is **5 MPH**.
4. All vehicles parked on campus by the student must be registered and display a valid parking permit.
5. Student must park only in the designated student parking lot(s). If you drive a different car on any given day that has not been registered to park campus, **park legally on the street until you get that car registered** – failure to do so will result in a ticket.
6. The parking permit must be visibly displayed **on the rearview mirror**. Failure to display permit is a parking violation.
7. The parking permit is valid until the end of the school year. Please renew the permit at the beginning of every school year.
8. Parking permits are issued for the sole use of the purchaser and are not transferable.
9. All parking is forward facing only – no backing into parking stalls is allowed.
10. Illegal parking will be towed at owner's expense and on-campus parking privileges will be revoked.
11. Students engaging in illegal acts, such as **burning rubber, reckless driving, or speeding**, will have their **parking privileges revoked** and may be subject to further disciplinary action.

Illegal Parking:

1st Offense - \$25 ticket

2nd Offense - \$50 ticket +

Car may be towed at owner's expense;

On-campus parking privileges will be revoked

3rd Offense - \$75 ticket
