

A.W. BROWN LEADERSHIP ACADEMY (AWBLA) BOARD REGULATIONS GOVERNING SCHOOL MARSHALS

The purpose of these regulations is to meet the requirements of CKE (LEGAL).

- An AWBLA School Marshal must adhere and operate in accordance with Texas Education Code Sec. 37.0811. An AWBLA School Marshal may make arrests and exercise all authority given to peace officers under Section 2, Chapter 2, Article 2.127, Code of Criminal Procedure, but only to the extent necessary to prevent or abate the commission of an offense that threatens serious bodily injury or death of students, faculty, or visitors on school premises, provided, however, an AWBLA School Marshal may not issue a traffic citation for a violation of Chapter 521, Transportation Code, or Subtitle C, Title 7 Transportation Code. An AWBLA School Marshal may access a handgun only under circumstances that would justify the use of deadly force under Section 9.32 or 9.33 of the Penal Code.
- 2. An AWBLA School Marshal may only carry an approved handgun...
 - a) in compliance with the legal requirements for a licensed concealed handgun carrier and,
 - b) at any AWBLA campuses or properties whether leased or owned. An AWBLA school marshal may carry an approved handgun on the physical premises of all district campuses.
- 3. An AWBLA School Marshal must use commercially produced holsters that provide adequate retention to secure the firearm. No firearms may be allowed to be kept in purses, handbags, backpacks, or an unsecured accessory. As of September 1, 2021, School Marshals may be allowed to carry a concealed handgun on the physical premises where they work, irrespective of the marshal's primary duties in accordance to S.B. 741.
- 4. Any approved handgun carried by or within access of an AWBLA school marshal must be loaded only with frangible ammunition designed to disintegrate on impact for maximum safety and minimal danger to others as approved by TCOLE. Such frangible ammunition is authorized to be purchased by the District.

- 5. An AWBLA School Marshal's status as a "school marshal" becomes inactive on:
 - a) August 31 occurring after the second anniversary of licensure under S.B. 785.
 - b) Suspension or revocation of the employees concealed handgun license.
 - c) Termination of the employee's employment or being placed on administrative leave with AWBLA.
 - d) Notice from the Board that the employee's services as School Marshal are no longer required.
 - e) Violation of any AWBLA policy or regulation applicable to an AWBLA School Marshal.
- 6. An AWBLA School Marshal will be responsible for providing his own duty handgun and holster. Each duty handgun must the following requirement:
 - a) The AWBLA Superintendent will maintain a record of any handgun an AWBLA School Marshal is authorized to carry.
 - b) An AWBLA School Marshal's list of approved duty handguns may change during the school year so long as each handgun meets the requirements hereof before it is used in service.
- 7. An AWBLA School Marshal must complete and pass the TCOLE weapons qualification course of fire. An AWBLA School Marshal must qualify with all firearms that he has registered. An AWBLA School Marshal must also demonstrate weapons proficiency to the satisfaction of the TCOLE.
- 8. An AWBLA School Marshal will be required to attend active shooter training provided by the TCOLE and/or other local agencies.
- 9. An AWBLA School Marshal must meet the requirements set by the Commissioner of Education in order to conduct an "active threat" school safety exercise as of September 1, 2021 according to S.B. 168.
- 10. An AWBLA School Marshal has immunity from liability as of September 1, 2021 according to H.B. 1788

ADDENDUM

The following addendum amends the current school marshal policy to reflect the following updated regulations:

2. An AWBLA School Marshal may only carry an approved handgun...

b) at any AWBLA campuses or properties whether leased or owned. An AWBLA school marshal may carry an approved handgun on the physical premises of all district campuses.

- 3. An AWBLA School Marshal must use commercially produced holsters that provide adequate retention to secure the firearm.
