Marion County School Nutrition program is pleased to announce that student meals will be at no cost for the 2023-2024 school year! After School Snack Program is available to students in an organized after school activity at no cost.

MEALS PROVIDED AT NO COST FOR STUDENTS (ONE MEAL PER STUDENT):

Lunch and Breakfast	\$0.00 (Students Only)
Faculty & Staff Breakfast	\$1.50
Faculty & Staff Lunch	\$3.25
Visitor Breakfast	\$2.00
Visitors Lunch	\$3.75
Visitors Holiday Lunch	\$5.00 (If applicable)

ALA CARTE AND EXTRAS

Students are not permitted to charge extras. If you want your student to purchase extras, please send cash daily or make prepayments on their lunch account.

PERSONAL CHECKS

Personal checks are accepted for the amount you want in your child/children's account. Checks should be made payable to your school cafeteria. Change cannot be given to the student for other activities. **Checks must have two phone numbers and physical address or they will be rejected. Payliance collects returned checks for \$50.00 fee. May write info by hand on check.**

ONLINE MEAL PAYMENTS

MyPaymentsPlus (www.mypaymentsplus.com), online service that offers you the convenience and information you need to manage your student's account. This system could eliminate the need to send checks to school or worry about lost or forgotten money, and speeds up serving lines in the cafeteria.

At **no cost**, MyPaymentsPlus allows any family to:

- Check your student's current account balance
- Monitor the items your student has been purchasing in the school lunchroom
- Create settings to receive email notifications when the account reaches a low balance

For a **small program fee**, MealpayPlus allows any family to:

- Make a prepayment into your student's account using a check, credit card, or debit card at www.mypaymentsplus.com.
- Create settings to automatically replenish your student's account when it reaches a low balance.

All parents may (even if you do not prepay for your student's meal account) create an account at no cost through www.mypaymentsplus.com or you will find this link on the Marion County Schools website - www.marionschools.org. To create a new account, follow the onscreen directions and register your student using his/her Student ID number (7 digits). If your child is a middle or high school student, you will find the Student ID number on the report card. If your child is in elementary school and you do not know their ID number, please email us at dtaylor@mctns.net and give us your child's full name, grade, and the school. We will email your child's ID number back to you. Email will be processed quickly as possible. **We ask that you do not call the school office or the lunch room.**
